AN ORDINANCE RELATED TO THE ANNEXATION OF CERTAIN REAL PROPERTY CONTAINING A TOTAL OF 122.2 ACRES, MORE OR LESS, OWNED BY SUE W. TONCRAY, GEORGE T. BURGESS AND JOHANNA R. BURGESS, HUSBAND AND WIFE, BOB G. GRIFFITH, BOB G. GRIFFITH, TRUSTEE OF BETTY YANCEY GRIFFITH EXEMPT FAMILY TRUST, AND LINDA W. REYNOLDS, SITUATED ADJACENT TO AND NORTH OF THE CITY OF GEORGETOWN, KENTUCKY, AND LYING ALONG THE EASTERLY RIGHT-OF-WAY LINE OF U.S. HIGHWAY 25 NORTH (CINCINNATI ROAD) IN SCOTT COUNTY, KENTUCKY.

WHEREAS, the owners, SUE W. TONCRAY, whose address is 300 East Jackson Street, Georgetown, KY 40324, GEORGE T. BURGESS and JOHANNA R. BURGESS, husband and wife, whose address is 110 Roxie Lane, Georgetown, KY 40324, BOB G. GRIFFITH, whose address is 307 North Broadway, Georgetown, KY 40324, BOB G. GRIFFITH, TRUSTEE OF BETTY YANCEY GRIFFITH EXEMPT FAMILY TRUST, whose address is 307 North Broadway, Georgetown, KY 40324 and LINDA W. REYNOLDS, whose address is 3521 Hidden Cave Circle, Lexington, KY 40513 have consented to the annexation of certain real property consisting of a total of 122.2 acres, more or less, situated adjacent to and north of the City of Georgetown, Kentucky, and lying along the easterly right-of-way line of U.S. Highway 25 North (Cincinnati Road) in Scott County, Kentucky, and

WHEREAS, all appropriate steps required under Chapter 81A of the Kentucky Revised Statutes have been performed or waived; and

WHEREAS, a copy of said consent having been made a part of the record in this matter and available for review with the minutes of this meeting; and

WHEREAS, said property is now embraced within the County of Scott, Kentucky, and is contiguous to the existing City Limits and, having urban character, is appropriate for annexation in its entirety to the City of Georgetown.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF  
GEORGETOWN:**

SECTION I. PURPOSE: The hereinafter described real property is urban in character and is contiguous to the existing City Limits of the City of Georgetown. It is, therefore, desirable to annex this property to the City of Georgetown, extending the boundaries of the City to include this property described as follows:





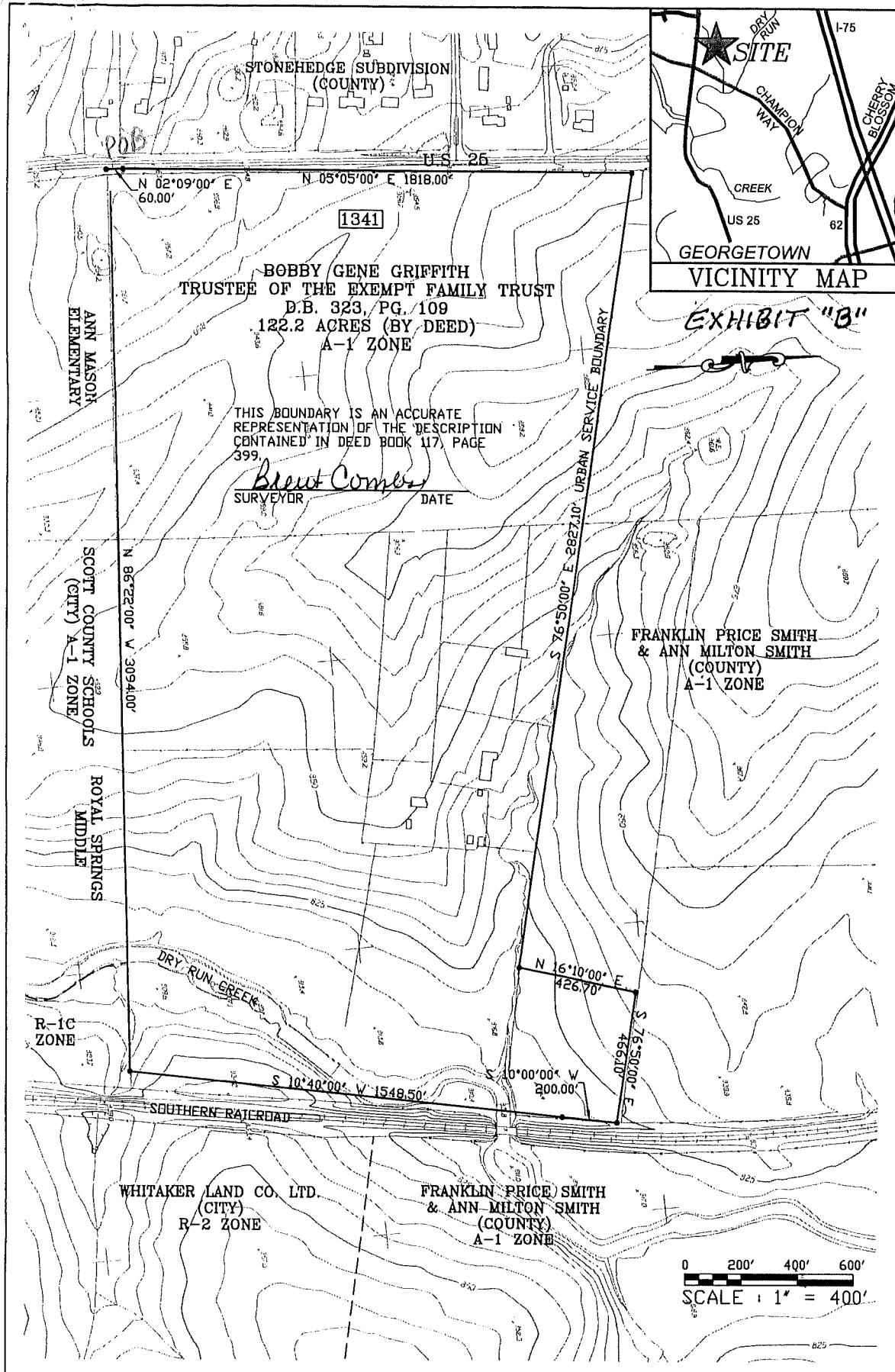
EXHIBIT "A"

Legal Description

The following described real estate lying north of Georgetown, Scott County, Kentucky, on U.S. Highway 25, more particularly described as follows, to-wit:

Beginning at a point in the right-of-way of U.S. Highway 25, corner to John L. Drake, said corner being approximately 1.7 miles north of Georgetown, Scott County, Kentucky; thence N 2° 09' E 60 feet; N 5° 05' E 1818.00 feet with the right-of-way of U.S. Highway 25 to the corner of Price estate; thence with the lines of Price estate S 76° 50' E 2827.10 feet; N 16° 10' E 426.70 feet; S 76° 50' E 466.10 feet to the right-of-way of the Southern Railroad; thence with said right-of-way S 10° W 200 feet; S 10° 40' W 1548.5 feet to a point, thence with a new division line N 86° 22' W 3094.00 feet to the point of beginning, and containing 122.2 acres, more or less.
