AN ORDINANCE ANNEXING CERTAIN UNINCORPORATED TERRITORY BY THE CITY OF GLENCOE, GALLATIN COUNTY, KENTUCKY

WHEREAS, The City Council of the City of Glencoe, Kentucky, on January 9, 2006 passed and approved an ordinance stating its intent to annex to the City of Glencoe, Kentucky, by extending a boundary line of the City to include certain unincorporated territory which in now embraced within the county of Gallatin, adjoining the present boundary line of the City of Glencoe, Kentucky, which is hereinafter more properly described; and

WHEREAS, The City of Glencoe has met in session on December 16, 2005 and passed the first reading of the intent to annex ordinance and published in the Gallatin County News on December 21, 2005 pursuant to KRS 424.130 to KRS 424.140; and

WHEREAS, the City of Glencoe on December 21, 2005 published in the Gallatin County News a Public Notice to the residents within the area being annexed pursuant to KRS 424.130 to KRS 424.140; and

WHEREAS, The City of Glencoe on December 19, 2005 pursuant to KRS 81A.425, mailed by first class mail at the Glencoe Post Office the required notices to the property owners within the area being annexed; and

WHEREAS, The City of Glencoe on January 9,2006 met in Regular session passed the second reading of ordinance no. 2005-12-16 intent to annex, and published it in the Gallatin County News on January 11, 2006 pursuant to KRS 424.130 to KRS 424.140; and

WHEREAS, as required by KRS 81A.420(3), in not less than sixty (60) days after the enactment of the ordinance, if no petition has been received by the mayor as set out herein, or within sixty (60) days of the certification of election results in which less than fifty-five percent (55%) of those persons voting opposed annexation, the legislative body may enact an ordinance annexing to the city the territory described in the ordinance.

NOW, THEREFORE, BE IT ORDAINED: that there is hereby annexed to the City of Glencoe, Kentucky by extending the boundary line of the City to include the same, that certain unincorporated territory which is now embraced within the County of Gallatin adjoining the present boundary line of the City of Glencoe, Kentucky, described as follows, to wit:

SECTION 1

The attached list shall serve as reference to all properties included in this ordinance and all information was obtained at the Gallatin County PVA and the Gallatin County Clerks

Office and all deeds shall become part of this ordinance describing the metes and bounds of each properties included in this ordinance # 04102006, Attachment (A).

SECTION II

Annexation of this area to the City of Glencoe is desirable due to its potential for development and advantages to be derived by all concerned from the annexation of this area without unreasonable delay.

SECTION III

All ordinances, resolutions and orders or parts thereof, in conflict with the provisions of this ordinance or to the extent of the conflict, are hereby repealed.

SECTION IV

The Glencoe City Council hereby directs that this ordinance shall be published in the Gallatin County Newspaper in said manner and form as required by State Law.
