CALLAWAY CIRCUIT COURT

In the Matter Of The Incorporation of

CITY OF Glencoe, Kentucky

This matter having come on the Partition of James E. Cole and one hundred twenty-seven (127) other petitioners for a Judgment of this Court establishing the City of Glencoe, Kentucky, and it appearing to the Court that the herein considered Petition has been timely and properly filed, that the notice prescribed by law has been given and that more than one hundred, twenty-five (125) inhabitants live within the proposed boundaries of the City of Glencoe, Kentucky, and the Court being informed that more than two-thirds of the voters residing in the proposed boundaries had signed said petition, and the Court being sufficiently advised, Now Therefore,

It Is Ordered, Adjudged and Decreed, and by these presents this Court does hereby establish the City of Glencoe, Kentucky, and the boundaries of the said city shall be as follows:

LEGAL DESCRIPTION OF PROPOSED INCORPORATION BOUNDARY FOR CITY OF  
CLEMCO, CALLAWAY COUNTY KENTUCKY.

Located generally in Callaway County Ky. around and adjacent to the intersection of the L & N Railroad and Ky. Highway # 127 (formerly Ky. Highway # 16) and described more particularly by notes and bounds as follows:

The reference point of this description is the intersection of the centerline of the railroad track of the said L & N RR with the centerline of said Ky. Highway # 127. From said reference point run along the centerline of said Highway S 6-30 W 30 feet to a point in the West right of way line of said State Highway, the point of beginning of the boundary of Glencoe to be described therein: Thence from said point of beginning and crossing said Highway W 83-00 N 434.8 feet to a point in the East line of a culminous paved street: Leaving said street N 4-50 W 294.8 feet to a point therein: Thence N 10-37 E 721.5 feet to a point in the center of the Polson Road opposite a roadway or cuttings leading across the railroad: Thence along the center of the said Polson Road N 61-51 E 237.4 feet to a point therein: Thence leaving said Polson Road and crossing said railroad N 20-40 W 333.1 feet to a point in the South East Line of said point therein: Thence leaving said roadway N 39-31 E 470 feet to a point N 57-14 W 814.6 feet to a point near a drain: Thence N 87-16 W 556.8 feet to a point in the stone roadway: Thence along said East line of said roadway N 2-44 W 302.8 foot to a point near the center of the railroad: Thence N 5-25 W 985 feet to a point of said highway N 89-35 W 150 foot to a point: Thence S 10-20 E 680.60 foot to a point 219.5 feet North as measured at right angles thereto, of the center of a street: Thence parallel to said street S 83-30 W 636.80 foot to a point: Thence N 83-30 E 390 feet to another street and 230 feet West thereof S 10-20 E 680.60 foot to a point in the South line of said railroad: Thence parallel to said railroad S 83-00 E 176 foot to a point: S 5-54 feet: Thence N 83-00 E 155 foot to a point in the West Right of Way line of said highway # 127: Thence with said right of way line N 8 7-00 E 225 feet to the place of beginning.

The above boundary embraces 70 acres.

Ordinance 1968-1

An ordinance annexing the hereinafter described territory to the City of Glencoe, Kentucky; The City Council of the City of Glencoe, Kentucky, does ordain as follows:

SECTION I: That whereas heretofore on February 23, 1961, this City Council did ordain and propose to annex the hereinafter described territory to the City of Glencoe, Kentucky, and whereas the same has been advertised as required by law, and whereas there was filed with the Gallatin Circuit Court a remonstrance action, which the said Gallatin Circuit Court did on October 26, 1968, dismiss in favor of the City of Glencoe, Kentucky;

SECTION II: Now therefore, the City Council of Glencoe, Kentucky, does hereby annex the following territory and property, lying entirely in Gallatin County, Kentucky, and contiguous to the boundaries of the City of Glencoe, Kentucky, to-wit:

The reference point of this description is a point S. 7-00 E., 10 feet from a steel pole N 7-00 W 225 feet from the point of beginning of boundary description of the City of Glencoe, Kentucky, as established by order of the Gallatin Circuit Court, dated November 22, 1960; from said reference point run approximately 437.5 feet S 83-00 W to a point where this line would intersect the line S 6-30 E. 210 feet long, as appears in the said description, if extended southwardly; thence S 7-00 E to the center of Eagle Creek, the Owen Gallatin Counties line, the point of beginning of the boundary of the area to be annexed to the City of Glencoe, Kentucky; thence back N 7-00 W to said point of intersection with the line N 83-00 E, 155 feet, appearing in the said order, if extended westwardly from the said reference point; thence S 83-00 W approximately 337.5 feet to a point intersecting the line, S 10-20 E, 680.60 feet, appearing in the said order, if extended southwardly; thence N 10-20 W, approximately 778.1 feet to a point in the south line in the L&N railroad where the lines S 10-20 E, 680.60 feet and N 83-30 E, 390 feet, appearing the said order, intersect; thence along the boundary described in said order N 83-30 E, 390 feet along said railroad line; thence along a fence and property line S 6-30 E, 210 feet; thence N 83-00 E, 276 feet to a point; thence parallel to US Highway No. 127 and 155 feet west of the west right of way line thereof, S 7-00 E, 564.0 feet; thence N 83-00 E, 155 feet to the point of reference hereof, and a point in the west right of way line of said highway; thence with said right of way line S 7-00 E, 225 feet; thence crossing said Highway No. 127, N 83-00 E, 434.8 feet, to a point in the east line of a bituminous paved street; thence along said line of said street N 4-90 W, 284-8 feet to a point therein; thence leaving the said street, N 87-03 E, 148 feet to a point in the property of Noel; thence leaving the said boundary as described in said order, S 4-50 E, approximately 275 feet to a point intersecting the line N 83-00 E, 434.8 feet, heretofore described, if extended easterwardly N 148 feet more or less to a point; thence along a further eastward extension of said line, N 83-00 E, 102 feet to a point; thence S 7-00 E, to the center of said Eagle Creek thence westwardly with the meanders of the center of said creek to

to the point of beginning.

SECTION 3. This ordinance shall become effective and be in full force upon its passage, adoption, and publication as required by law.
