BEGINNING at a point in the existing corporate limit line of the City of Glenview said point being also the southwest corner of Brittany Woods Subdivision Section Number 2 of record in Plat and Subdivision Book 18, Page 46 in the office of the Clerk of the County Court of Jefferson County, Kentucky; thence with said corporate limit line North 58 degrees 55 minutes East 2,015.73 feet to the original east line of Lime Kiln Lane, 30 feet wide, and with said east line North 32 degrees 55 minutes West 410.00 feet to a point; thence departing said corporate limit line with the north line of said Brittany Valley Woods Subdivision Section Number 2 and its extension South 58 degrees 55 minutes West 2,016.43 feet to the northwest corner of said subdivision, said point also being is the centerline of Glenview Avenue; thence with said centerline as shown on the plat of said subdivision South 32 degrees 10 minutes 30 seconds East 53.80 feet, South 39 degrees 24 minutes 30 seconds East 33 feet, South 46 degrees 00 minutes 30 seconds East 82.50 feet, South 36 degrees 16 minutes East 33.00 feet, South 24 degrees 01 minute East 66 feet, South 22 degrees 30 minutes 30 seconds East 66 feet, South 31 degrees 31 minutes East 66 feet and South 36 degrees 10 minutes East 14.07 feet to the point of beginning, containing 18.89 acres.

Ordinance No. 5, Series 1987

AN ORDINANCE DE-ANNEXING A CERTAIN PORTION OF THE CITY OF GLENVIEW, JEFFERSON COUNTY, KENTUCKY.

WHEREAS, the City of Glenview passed and approved Ordinance No. 1, Series 1987 on July 15, 1987, proposing to de-annex a certain portion of the City of Glenview; and

WHEREAS, the question of whether the certain portion of the City of Glenview should be de-annexed was put on the ballot of the regular election held Tuesday, November 3, 1987, for approval by the registered voters residing within the stated territory; and

WHEREAS, the question was approved by a simple majority of those registered voters of the stated territory voting on the question;

BE IT ORDAINED BY THE CITY OF GLENVIEW:

Section 1. De-annexation.

The City of Glenview hereby de-annexes certain territory presently located within the corporate limits of the city. The following described property is stricken from the corporate limits of the City as of the date of this ordinance.

Section 2. The property stricken is one tract described as:

BEGINNING at a point in the existing corporate limit line of the City of Glenview said point being also the southwest corner of Brittany Woods Subdivision Section Number 2 of record in Plat and Subdivision Book 18, Page 46 in the office of the County Clerk of Jefferson County, Kentucky; thence with said corporate limit line North 58 degrees 55 minutes East 2,015.73 feet to the original east line of Lime Kiln Lane, 30 feet wide, and with said east line North 32 degrees 55 minutes West 410.00 feet to a point; thence departing said corporate limit line with the north line of said Brittany Valley Woods Subdivision Section Number 2 and its extension South 58 degrees 55 minutes West 2,016.43 feet to the northwest corner of said subdivision, said point also being in the centerline of Glenview Avenue; thence with said centerline as shown on the plat of said subdivision South 32 degrees 10 minutes 30 seconds East 53.80 feet, South 39 degrees 24 minutes 30 seconds East 33 feet, South 46 degrees 00

minutes 30 seconds East 82.50 feet, South 36 degrees 16 minutes East 33.00 feet, South 24 degrees 01 minute East 66 feet, South 22 degrees 30 minutes 30 seconds East 66 feet, South 31 degrees 31 minutes East 66 feet and South 36 degrees 10 minutes East 14.07 feet to the point of beginning, containing 18.89 acres.

Section 3. This Ordinance shall take effect when passed, approved and published according to law.
