



IT IS THEREFORE ORDERED AND ADJUDGED that the following described area be, and it is hereby incorporated into a sixth class city known as City of Glenview Hills.

Located in Jefferson County, Kentucky.


BEGINNING at a point in the Westline of a 25' STRIP ADDED TO LIME KILN LANE as shown on the plat of GLENVIEW HILLS SECTION 2A recorded in P. & S. B. 23 P. 76 in the Office of the Clerk of the County Court of Jefferson County, Kentucky; said point also being the South corner of said 25' STRIP ADDED TO LIME KILN LANE; thence running through the lands of GLENVIEW HILLS SECTION 2B recorded in P. & S. B. 25 P. 42 in the above mentioned Clerk's Office, S. 56° 56' 30" W. 1500.00' to a point; thence continuing through the lands of GLENVIEW HILLS SECTIONS 2A and 2B as above-mentioned N. 33° 03' 30" W. 1500.00' to a point; thence continuing through the lands of GLENVIEW HILLS SECTION 2A as abovementioned N. 56° 56' 30" E. 1500.00' to a point in the West line of a 25' STRIP ADDED TO LIME KILN LANE as mentioned above; thence along said West line of the 25' STRIP ADDED TO LIME KILN LANE S. 33° 03' 30" E. 1500.00' to the point of beginning and containing 51.65 acres, more or less.




