On motion of the petitioners, it appearing that a petition has been filed pursuant to KRS 81.050 to establish the City of Goose Creek, that notice of the filing has been duly published, and that no defense has been interposed, and the Court being advised, it is, therefore, ORDERED & ADJUDGED that the following described area situated in Jefferson County, Kentucky is hereby established a city of the sixth-class known as Goose Creek, Kentucky, namely:

" Beginning at a point in the westerly line of Goose Creek Road as it intersects with the Southerly line of Goose Creek Subdivision, Section 3, recorded in Plat & Subdivision Book 24, Page 46, in the Office of the Clerk of Jefferson County, Kentucky, thence N. 35° 19' 40" W. along the westerly line of Goose Creek Road 1025.54 feet to a point intersecting with the northerly line of Goose Creek Subdivision, Section 1 recorded in Plat & Subdivision Book 22, Page 17, in the Office of the aforesaid Clerk, thence S. 53° 56' 20" W. along said line and as it extends into Goose

Creek Subdivision Section 2 recorded in Plat & Subdivision Book 23, Page 54, in the aforesaid Clerk's Office, for a distance of 1025.54 feet, thence S. 35° 19' 40" E. to the southerly line of the aforesaid Goose Creek Subdivision Section 2, thence N. 54° 00' 30" E. along said line and along said southerly line of Goose Creek Subdivision Section 3 until the point of beginning. "
