JUDGMENT

This matter came before the Court on the Petition of over three hundred individuals to incorporate an area as a sixth class city in Oldham County, Kentucky, pursuant to the provisions of KRS 81.050 and KRS 81.060. The Court conducted a hearing on March 13, 1990, and subsequently entered its Findings of Fact, Conclusions of Law on March 21, 1990, and made a preliminary judgment that the incorporation be approved. The Court, having considered all written statements received from registered voters subsequent to the hearing, in accordance with the Findings of Fact, Conclusions of Law, and having further considered the record, pleadings, memoranda of counsel, and arguments of all parties, hereby renders Final Judgment in this action.

WHEREFORE, IT IS HEREBY ORDERED AND ADJUDGED AS FOLLOWS:

- 1. The number of petitioners in favor of incorporation is in excess of the two-thirds required to sustain the request for incorporation.
- There is hereby incorporated and established in Oldham County, Kentucky, the City of Goshen, effective immediately upon entry of this Judgment.
- 3. The metes and bounds description of the boundaries of the City of Goshen is as set forth on the legal description attached hereto as Exhibit "A".
- 4. As of this date, there are approximately 514 registered voters in the City of Goshen. The population contained in the City of Goshen is,

 therefore, more than 300 and less than 999, and by reason of its population, the City of Goshen shall be and hereby is assigned to the sixth class of cities.

5. The City of Goshen shall operate under the commission plan form of government as described by KRS 83A.140, and the following persons be and hereby are appointed to hold the following offices until the next regular election at which City officers may be elected, at which time officers shall be elected by residents of the City:

Judgment as a permanent record in his office, all in accordance with KRS 81.060(5).

This is a final judgment, and there is no just reason for delay.
