ORDINANCE NO. 2 , 1986

AN ORDINANCE PROPOSING MERGER OF THE CITY OF DEVONDALE, KENTUCKY WITH THE CITY OF GRAYMOOR, KENTUCKY, TO FORM THE CITY OF GRAYMOOR-DEVONDALE, KENTUCKY, AND CALLING FOR AN ELECTION WITHIN THE CITY OF DEVONDALE TO DETERMINE THE DESIRES OF THE VOTERS.

WHEREAS, heretofore, by Ordinance No. 4, Series 1985, The City of Devondale proposed merger with the City of Graymoor to form the City of Graymoor-Devondale, and a special election to determine voters' desires regarding said proposed merger,

AND WHEREAS, the date chosen in said Ordinance No. 5 for said election was nullified by superceding provisions of The Constitution of The Commonwealth of Kentucky, and whereas the next regular election on November 4, 1986 is the earliest date on which to conduct an election for said purposes,

AND WHEREAS, the City of Devondale is desirous of re-enacting said earlier ordinance so as properly to submit said question to the voters in accordance with KRS 81.420 (1).

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF DEVONDALE, KENTUCKY:

SECTION 1. Merger

a. Pursuant to KRS 81.410 et seq., the City of Devondale hereby proposes merger with the City of Graymoor to form the City of Graymoor-Devondale.

SECTION 2. Call for Election

a. The City of Devondale, herein, calls for an election on Tuesday, November 4, 1986 to determine the desires of the citizens of Devondale as regards the proposed merger.

SECTION 3. Structure of Merger


a. All legislative offices shall be preserved and combined to constitute the legislative body of the proposed City of Graymoor-Devondale.

b. All non-legislative offices shall be extinguished by merger. A mayor shall be appointed by the Graymoor-Devondale legislative body within thirty (30) days of the effective date of merger.


c. All ordinances of both Devondale and Graymoor shall remain in full force and effect until such time as they may be repealed or amended. Should ordinances of both cities address the same subject in an inconsistent fashion, the ordinance which is in effect within the City of Devondale will take precedence in as much as Devondale is a city of the fifth class and Graymoor is a city of the sixth class.

d. All funds of both cities shall be combined, with the exception of the South Devondale Sewer Fund, which shall remain distinct and shall be utilized for its originally intended purpose.

SECTION 4. This Ordinance shall take effect upon its approval and publication as required by law.

AN ORDINANCE PROPOSING THE MERGER OF THE CITY OF DEVONDALE WITH THE CITY OF GRAYMOOR TO FORM THE CITY OF GRAYMOOR-DEVONDALE, KENTUCKY, AND CALLING FOR AN ELECTION WITHIN THE CITY OF DEVONDALE TO DETERMINE THE DESIRE OF THE VOTERS.

BE IT ORDAINED BY THE CITY OF DEVONDALE:

SECTION 1. Merger

a. Pursuant to the Kentucky Revised Statutes, sections 81.410 through 81.440, the City of Devondale hereby proposes merger with the City of Graymoor to form the City of Graymoor-Devondale, Kentucky.

SECTION 2. Call for Election

a. The City of Devondale, herein, calls for a special election to be held Tuesday, December 3, 1985, to determine the desires of the citizens of Devondale as regards the proposed merger.

SECTION 3. Structure of Merger


a. All legislative offices shall be preserved and combined to constitute the legislative body of the proposed City of Graymoor-Devondale.

b. All non-legislative offices shall be extinguished by merger. A mayor shall be appointed by the Graymoor-Devondale legislative body within thirty (30) days of the effective date of merger.


c. All ordinances of both Devondale and Graymoor shall remain in full force and effect until such time as they may be repealed or amended. Should ordinances of both cities address the same subject in an inconsistent fashion, the ordinance which is in effect within the City of Devondale will take precedence inasmuch as Devondale is a city of the fifth class and Graymoor is a city of the sixth class.

d. All funds of both cities shall be combined, with the exception of the South Devondale Sewer Fund, which shall remain distinct and shall be utilized for its originally intended purpose.

SECTION 4. This ordinance shall take effect upon its approval and publication as required by law.
