ORDINANCE NO. 5, SERIES 1987

AN ORDINANCE ADOPTING THE ORDINANCES ENACTED BY THE CITY OF GRAYMOOR AND THE CITY OF DEVONDALE PRIOR TO THEIR MERGER.

WHEREAS, the City of Graymoor and the City of Devondale each had passed and approved ordinances prior to the merger of the two cities; and,

WHEREAS, the City Council of the City of Graymoor-Devondale finds it desirable to adopt certain ordinances enacted by the City of Graymoor and the City of Devondale where the City Council of the City of Graymoor-Devondale has not passed similar ordinances,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF GRAYMOOR-DEVONDALE:

SECTION 1. The City Council of the City of Graymoor-Devondale hereby adopts the ordinances enacted by the City of Graymoor and the City of Devondale which are not inconsistent with ordinances enacted by the City Council after the merger of the two cities.

SECTION 2. Where any of the ordinances in effect at the time of the merger and hereby adopted are inconsistent with one another, the ordinances enacted by the City of Devondale will control.

SECTION 3. The Mayor of the City of Graymoor-Devondale is hereby authorized and directed to publish this Ordinance.
