EX PARTE

On Motion of the Plaintiffs, by counsel, and it appearing that a Petition has been filed pursuant to KRS 81.050 to establish the City of Green Spring; that notice of said filing having been duly advertised pursuant to KRS Chapter 424; that all of the statutory requirements for incorporation of said City having been met; and the Court be well and sufficiently advised;

IT IS THEREFORE ORDERED AND ADJUDGED that the following described area be, and it is hereby incorporated into a sixth Class City known as City of Green Spring, situated in Jefferson County, Kentucky, to-wit:

Beginning at a point within the property of James W. Ewing, N. 63° 05' 12" W, 496.45 feet from the center-line of W01f Pen Branch Road and N 63° 05' 12" W, 567.84 feet from the most northerly point in the boundary line of Green Spring Subdivision, Section 11, as recorded in Deed Book 26, Page 93; thence S 63° 05' 12" E. 2640.00 feet to a point within the property of George G. Brown; thence S 26° 54' 48" W, 2640.00 feet to a point within the property of Katie Rupp; thence N 63° 05' 12" W, 2640.00 feet to a point within the property of Citizens Fidelity Bank and Trust Company; thence on a line which coincides with the West boundary line of Green Spring Subdivision, Section I, N 26° 54' 48" E, 2640.00 feet to the point of beginning, containing in all 160.00 acres.
