### AN ORDINANCE

#### OF THE

#### CITY OF GREENSBURG

RELATING TO THE PROPOSAL TO ANNEX INTO THE CITY OF GREENSBURG OF CERTAIN UNINCORPORATED AREAS ADJACENT TO THE CURRENT INCORPORATED BOUNDARIES OF THE CITY OF GREENSBURG

WHEREAS, it has come to the attention of the City Council of the City of Greensburg that certain unincorporated areas which are adjacent to the current incorporated boundaries of the City should be annexed into the City of Greensburg by reason of the density of their population, the industrial use of the lands, the subdivisions of said lands, the commercial use of said lands, or by reason of said lands being suitable for development for urban purposes; and

WHEREAS, the City Council has determined that the annexation of such unincorporated areas would be beneficial to the City and to the residents and owners of property in such areas and that it is desirable to accomplish said annexation;

NOW THEREFORE, BE IT ORDAINED by the City of Greensburg that the following unincorporated areas be, and are hereby proposed to be annexed into the incorporated boundaries of the City of Greensburg, Kentucky, and made a part thereof:

## SECTION ONE: DESCRIPTION OF PROPERTY AND BOUNDARY

FIRST TRACT: Being that tract of land lying and being in Green County, Kentucky, on Autumn Drive adjacent to Long Meadow Subdivision, commonly known as the new "Dawson Judd Property", and being more particularly described as follows:

# FIRST TRACT:

BEGINNING at the Northeast corner of the Gary Ferguson property at the Western right-of-way of Autumn Drive; thence with Autumn Drive N 40 1/4 E 171 feet to the corner of the

Joe Rogers, Jr. property; thence with said Rogers property N 57-45 W 100 feet; thence S 46-23 W 175 feet; thence S 58-05 E 119 feet to the beginning.

#### SECOND TRACT:

A parcel of land lying in Green County, Kentucky, being part of the the Victor Griffiths property as recorded in Deed Book 124, page 168, and more particularly described as follows:

The intention of this description is to be used to convey the property bounded on the West by Greensburg Village, on the North by Joseph Rogers, Jr. and on the East and South by tracts belonging to William O. Moore; the bearings and distances are calculated using previous plats and descriptions:

BEGINNING at corner to Greensburg Village and Joseph Rogers, Jr.; thence with Greensburg Village S 51-52-11 W 180 feet+ to corner to William O. Moore; thence with Moore S 58-05 E 119 feet+ to corner to Moore; thence with Moore N 46-23 E 175 feet to the line of Joseph Rogers, Jr.; thence with Rogers N 57-45 W 100 feet to the beginning.

This being the same property Dawson Judd and his wife, Radena Judd, acquired by deed of Ronnie Dale Milby and his wife, Vicki Milby, dated July 29, 1991, and of record in Deed Book 166, page 712, Green County Court Clerk's office.

The Greensburg City Council met in regular session Monday, May 4, 1992, Mayor Bill Edwards presiding. The council members were all present.

The minutes of the previous meeting were read and approved on motion by Lawrence Gupton, second by Ada Mae Wilcoxson.

A delegation of citzens from Shady Lane appeared before the council to discuss several problems, including the need for a street light at this end of the street going through the trailer park, loud music, cable office parking that blocks the road, darinage, vehicles driving too fast and the hazards of getting from Shady Lane to Columbia Highway.

The delegation was advised that some of their concerns would be helped by projects already underway.

would be helped by projects already underway.

Attorney Mindy Milby and Willie Milby, holder of the franchise for garbage collection, came beforethe council to discuss increased costs in fees at the Pulaski County Landfill where Milby dumps the solid waste from the city. The rate is now \$6.13 per cubis yard.

This will result in additional dumping fees for city garbage of \$1500 a month.

After discussion a motion was made by Lawrence Gupton, second by Bill Parson, to approve a 13.5% across the board rate increase in thegarbage rates and to form a committee to aggressively study recycling to see where garbage is coming from and where it can go. All voted age.

The ordinance on the annexation of the Dawson Judd property on Autumn Drive was given a second reading and adopted on motion by Woodson Risen, second by Ada Mae Wilcoxson. All voted aye.

Mayor Edwards brought up the concern related to large decaying

Mayor Edwards brought up the concern related to large decaying trees in the vicinity of the footbridge. Some of these are on city property and some are on property belonging to Jim Durham. Mr. Durham indicates he will share the cost of having the trees cut and that the projected cost is \$1200. On motion by Lawrence Gupton, second by Billie Fields, council unanimously voted to do the same.

Council considered the bids that had been recieved on the landscaping of city hall and finding them higher than the amount approved last month, voted to increase the allocation by \$300 on motion by Lawrence Gupton, second by Woodson Risen.

There was a lack of consensus on taking action on the property maintenance ordinance and it was agreed to meet for a special called meeting of the council Monday, MAy 18 at 5:30 to act on the ordinance. In the meantime, a committee compased by Bill Parson, Woodson Risen any problems seen in the interpretation or enforcement of the ordinance.

The mayor announced the state plans to let the bid for the widening of 61/68, June 19.

The Park Board has asked for assitance from the city with its program. It was pointed out that the city has in the past not charged for the water used in cleaning and filling the pool at the beginning of theseason and that will continue. The city also pays a light bill at the park each month in the amount of approximately \$105. As the budget is being prepared consideration will be given to giving some additional help.

Council was informed of an unopened alley in the Shreve Addition, going north from Shreve Avenue along property owned by Kevin Hunt on the west and Polly Posey on theright. On motion by Bill Parson, second by Ada MAe Wilcoxson, council unanimously voted to have Attorney Sam Moore take necessary action to close the alley and make the allowable distribution of the right-of-way to

the abutting property owners.

Meeting adjourned on motion by Lawrence Gupton, second by

Woodson Risen.
