AN ORDINANCE OF THE CITY OF GREENSBURG

RELATING TO THE ANNEXATION INTO THE CITY OF
GREENSBURG CERTAIN UNINCORPORATED AREAS ADJACENT TO THE
CURRENT INCORPORATED BOUNDARIES OF THE CITY OF GREENSBURG

WHEREAS, it has come to the attention of the City Council of the City of Greensburg that certain unincorporated areas which are adjacent to the current incorporated boundaries of the City should be annexed into the City of Greensburg because such areas have become urban in character by reason of population density; and

WHEREAS, the City Council has determined that the annexation of such unincorporated areas would be beneficial to the City and to the residents and owners of property in such areas and that it is desirable to accomplish said annexation; and

WHEREAS, the City Council has adopted an Ordinance proposing to annex such areas and less than 50% of said owners have objected to said annexation within the 60 day time limitation;

WHEREAS, the City Council has determined that the annexation of such unincorporated areas would be beneficial to the City and to the residents and owners of property in such areas and that it is desirable to accomplish said annexation;

NOW THEREFORE, BE IT ORDAINED by the City of Greensburg that the following unincorporated areas be, and are hereby annexed into the incorporated boundaries of the City of Greensburg, Kentucky, and made a part thereof:

SECTION ONE: DESCRIPTION OF PROPERTIES AND BOUNDARIES

BEGINNING at the point on the Eastern right of way of Old Hodgenville Road where it intersects the Southern right of way of Hidden Valley Road; thence running straight across said Old Hodgenville Road, in a line perpendicular to the right of way, to the Western right of way of said Old Hodgenville Road; thence running in a Northerly direction with said Western right of way to the Northern boundary of Hillyiew Acres Subdivision; thence with the Northern boundary of said Hillview Acres Subdivision in a Westerly direction to a point that is 230 feet from, the Western right of way of Old Hodgenville Road; thence running in a Northerly direction, in a line that is 230 feet West of, and parallel to, said Old Hodgenville Road, to the Southern boundary of the Greensburg Cumberland Presbyterian Church property (Deed Book 101, page 297); thence in a Northern direction around the perimeter of said Cumberland Presbyterian Church property (Deed Book 101, page 297) so as to include all of said property, to the property of Susan Montgomery (Deed Book 156, page 93); thence in a Northern direction around the perimeter of said Susan Montgomery property (Deed Book 156, page 93), so as to include all of said property, to another tract of Susan Montgomery property (Deed Book 193, page 772); thence in a Northern direction around the perimeter of said Susan Montgomery property (Deed Book 193, page 772), so as to include all of said property, to the Western right of way of said Old Hodgenville Road; thence running in a Northern direction with the Western right of way of Old Hodgenville Road to the Southern right of way of the New Hodgenville Road (U.S. Hwy. #61); thence running in an Easterly direction with said Southern right of way of the New Hodgenville Road (U.S. Hwy. #61) to the Western right of way of North Main Street/Campbellsville Road/Ky. Hwy. #61/U.S. Hwy. #68; thence running in a Southerly direction with said Western right of way to the city limits of the City of Greensburg; thence running in Southern and Western courses with the meanders of said city limits to the beginning.

SECTION TWO: SEVERABILITY

In the event any portion of this Ordinance should be declared invalid, unlawful or unconstitutional, then such declaration or action shall not affect the validity of the remaining portions of said Ordinance. THIS ORDINANCE given a first reading by the City Council this the day of October, 2004.
