AN ORDINANCE
OF THE
CITY OF GREENSBURG

RELATING TO THE ANNEXATION INTO THE CITY OF GREENSBURG
OF CERTAIN UNINCORPORATED AREAS ADJACENT TO THE CURRENT
INCORPORATED BOUNDARIES OF THE CITY OF GREENSBURG

* * *

WHEREAS, it has come to the attention of the City Council of the City of Greensburg that certain unincorporated areas which are adjacent to the current incorporated boundaries of the City should be annexed into the City of Greensburg by reason of the density of their population, the industrial use of the lands, the subdivisions of said lands, the commercial use of said lands, or by reason of said lands being suitable for development for urban purposes; and

WHEREAS, the City Council has determined that the annexation of such unincorporated areas would be beneficial to the City and to the residents and owners of property in such areas and that it is desirable to accomplish said annexation;

NOW THEREFORE, BE IT ORDAINED by the City of Greensburg that the following unincorporated areas be, and are hereby annexed into the incorporated boundaries of the City of Greensburg, Kentucky, and made a part thereof:

SECTION ONE: DESCRIPTION OF PROPERTIES AND BOUNDARIES

FIRST TRACT: Being that tract of land lying and being in Green County, Kentucky, on Shady Lane just off Columbia Highway, commonly known as the new "City of Greensburg Sewer Treatment Plant" and being more particularly described as follows:

BEGINNING at a point on the centerline of Shady Lane in the middle of Clover Lick Creek; thence with the centerline of said Shady Lane S 78-03-01 E 53.00 feet, S 81-56-01 E 91.00 feet and S 78-57-01 E 256.11 feet; thence S 11-51-51 W 545.00 feet to a stake, a new division line in the lands of Sam Moore; thence N 79-30-34 W 400 feet to the center of Clover Lick Creek, a new division line in the lands of Sam

Moore; thence with the center of said creek and its meanders N 17-10-29 E 38.71 feet, N 8-51-57 E 98.21 feet, N 13-15-55 E 78.97 feet, N 20-18-45 E 54.14 feet, N 7-40-19 W 129.74 feet, N 20-39-15 E 33.96 feet, N 44-55-43 E 37.89 feet, N 14-16-08 E 37.03 feet and N 20-26-42 E 51.86 feet to the beginning, containing 5.092 acres, by survey of Walter L. Bowman, RLS #1804, dated June 28, 1990.

SECOND TRACT: Being that tract of land lying and being in Green County, Kentucky, on Shady Lane just off Columbia Highway commonly known as Moore's Trailer Park and being more particularly described as follows:

FIRST PARCEL:

BEGINNING at the northwestern corner of the Farmers Investment Company, Inc. tobacco warehouse property where it joins the property of Moore Enterprises; thence in a westerly direction with the line of Moore Enterprises to the Eastern edge of Moore's Trailer Park road; thence in a northerly direction with the eastern edge of said road approximately 490 feet to the southern edge of Shady Lane road; thence in a westerly direction with the southern edge of said road to the new City of Greensburg Sewer Treatment Plant site; thence S 11-51-51 W 545 feet to a stake; thence S 79-30-34 E to a point which is 200 feet West of Moore's Trailer Park Road; thence in a straight line parallel to said Moore's Trailer Park Road in a Southerly direction to the northern boundary of the property deeded to Sam W. Moore et ux by E.J. Milby et ux dated April 24, 1957; thence S 69 3/4 E in a straight line to the western boundary of the Farmers Investment Company, Inc. tobacco warehouse property; thence N 8 1/2 W with said tobacco warehouse property line to the beginning.

SECOND PARCEL:

BEGINNING at a point in the center of a farm road (which road leads to Columbia Highway-U.S. Highway #68), said point being near the southwest corner of the first tract of the Ben E. Burress property (Deed Book 153, page 265); thence with the center of said road as follows: N 76-20 W 289.8 feet; N 75-33 W 303.7 feet to a point in the center of said road, said point being near the southeast corner of the second tract said Burress property; thence leaving said road and with the line of said second tract N 14-39 E 187.9 feet to an iron post in the line of the Kentucky State Highway Department; thence with the line of said Kentucky State Highway Department S 69-54 E 590.9 feet to an iron post in the line of said Kentucky State Highway Department property, corner of said Burress first tract; thence with the line of said first tract S 12-17 W 126 feet to the beginning, containing 2.14 acres.

THIRD PARCEL:

BEGINNING at an iron pin on the Northern edge of Shady Lane which bears N 85 W 93 feet 2 inches from the Western right-

of-way of Kentucky Highway #61; thence N 10 W 131 feet 6 inches to the property line of Greensburg Lumber Company; thence in a Westerly direction with the line of said Greensburg Lumber Company to a corner and another line and corner of said Greensburg Lumber Company and a fence; thence with said line and fence in a Southerly direction to the Northern edge of Shady Lane; thence in an Easterly direction with the Northern edge of Shady Lane to the beginning.

SECTION TWO: SEVERABILITY

In the event any portion of this Ordinance should be declared invalid, unlawful or unconstitutional, then such declaration or action shall not affect the validity of the remaining portions of said Ordinance.

APPROVED the first reading of this Ordinance this 1ST day of October, 1990.

The Greensburg City Council met in regular session Monday, November 5, 1990. Mayor Bill Edwards presiding. Gupton, Posey, minutes.

Council discussed the continuing roof problems at the Huddleston Building. After discussion of the proposals received, it was agreed to advertise for bids to reroof the building. Motion for same was made by Lawrence Gupton, seconded by Woodson Risen. Advertisements to state work is to begin immediately, mansard roof to be removed and work to begin at the original square of the building using pre-fabricated trusses for construction of basic roof with guttering and insulation.

A final reading of the annexation ordinance was heard on the *Moose's Trailer Park* annexation of Shady Lane and the land to be purchased for the new wastewater treatment plant. The ordinance was adopted on motion by Lawrence Gupton, seconded by Billie Fields.

The mayor announced the Certified City Award dinner to be held in Louisville at which time we will be officially designated a Kentucky Certified City.



It was agreed to purchase a heater for the backhoe, and a gun burner for use when there are water or sewer line problems in freezing weather.

Meeting adjourned on motion by Fields, seconded by Posey.
