CITY OF HARDINSBURG
ORDINANCE NO. 96-12.2

**AN ORDINANCE ANNEXING CERTAIN UNINCORPORATED
TERRITORY BY THE CITY OF HARDINSBURG, KENTUCKY.**

WHEREAS, the City Council of the City of Hardinsburg, Kentucky, on December 9, 1996, passed and approved an ordinance stating its intent to annex to the City of Hardinsburg, Kentucky, by extending a boundary line of the City to include certain unincorporated territory which is now embraced within the County of Breckinridge, adjoining the present boundary line of the City of Hardinsburg, Kentucky, which is hereinafter more properly described; and

WHEREAS, the annexation was requested in writing by the Breckinridge County Industrial Authority.

Section One:

NOW, THEREFORE, BE IT IS HEREBY ORDAINED: that there is hereby annexed to the City of Hardinsburg, Kentucky by extending the boundary line of the City to include the same, that certain unincorporated territory which is now embraced within the County of Breckinridge adjoining the present boundary line of the City of Hardinsburg, Kentucky, described as follows, to wit:

ANNEXATION DESCRIPTION

Beginning at an unmarked point in present city limits as defined by an Ordinance passed by the City Council on December 6, 1976, at the SW corner of Rt. 60 & 992 North 1704 LF to SE the corner of Industrial Park Rd. & 60 intersection SW 656 LF to property owned by Breck. Co. Industrial Authority as delineated in Book 202, Page 520, SE 639 LF along property line of BC/A property to the intersection of Keenan O'Connell property SW 479 LF along property line of BC/A & Keenan O'Connell property to end of property, NW 453 LF along property line of BC/A to Industrial Road. 60 LF across Industrial Road to NW Side of ROW, NE 1132 LF along Industrial Road to Rt. 60 ROW. Across Rt. 60 RW to NE side. SE 1764 LF to existing city limits at NE corner of Rt. 60 & 992.

Section Two: It is further ordained and declared that any and all property within the said described boundaries be, and the same is hereby annexed as a part of the City of Hardinsburg, Kentucky.

Section Three: This ordinance shall take effect and be in force from and after its passage and publication as required by law.

Section Four: All ordinances or parts of ordinances in conflict are hereby repealed.

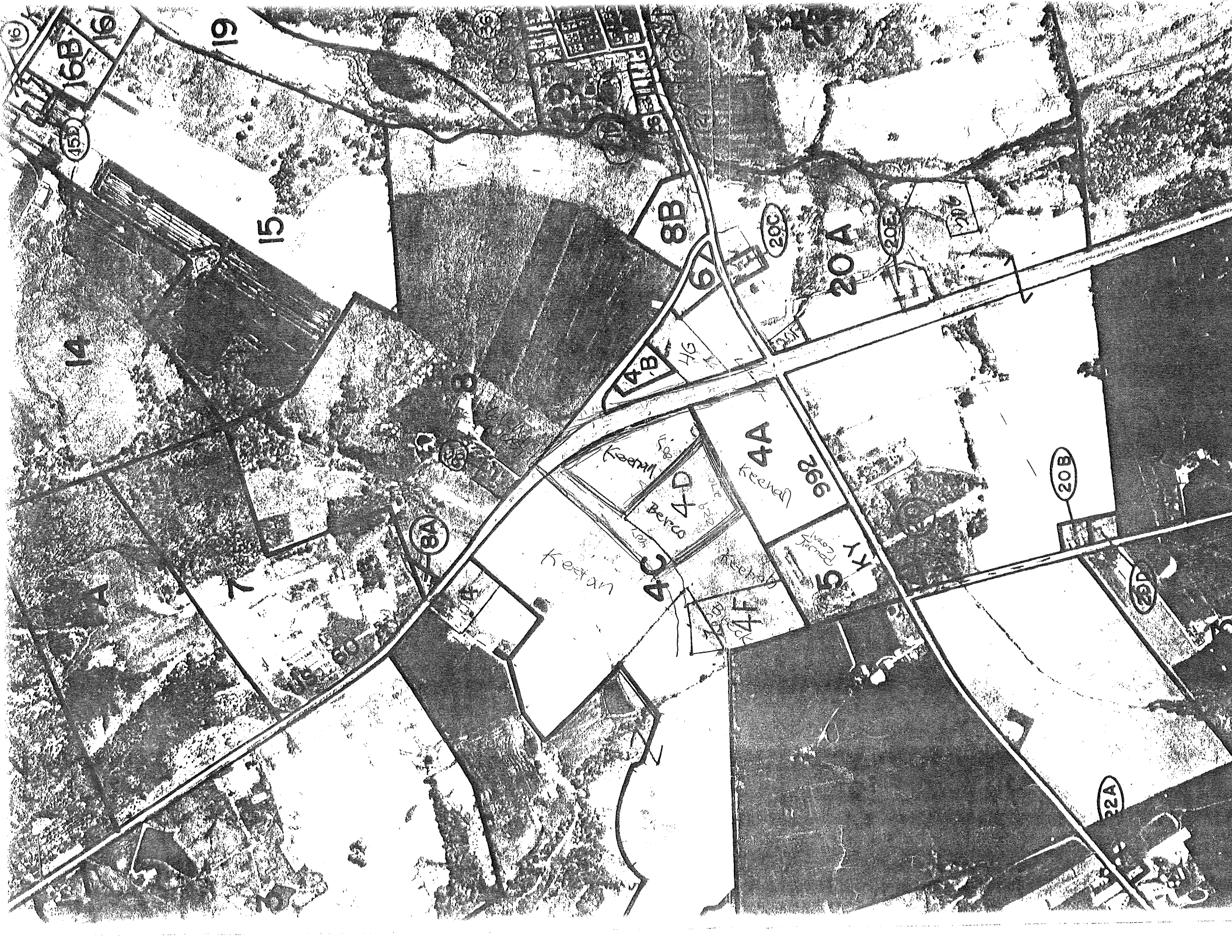
CERTIFICATION
