


CERTIFICATION OF ORDINANCE NO. 110.09

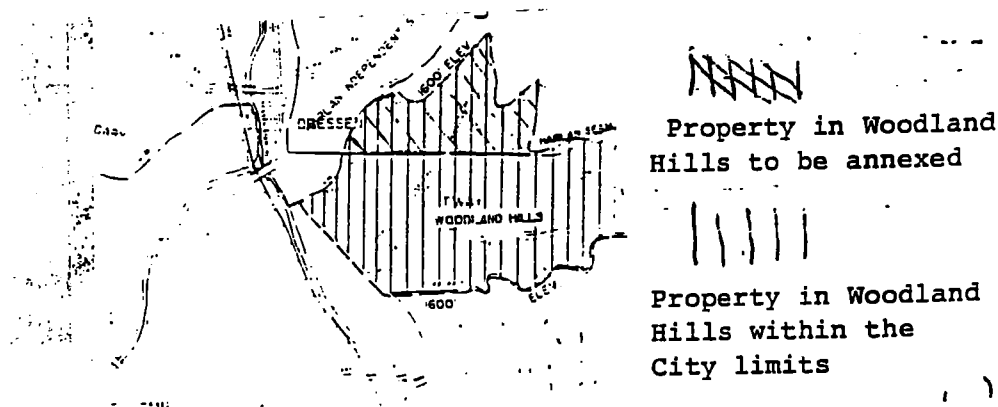

ANNEXATION ORDINANCE

Whereas, the City of Harlan by and through it City Council on July 16, 2001, passed a Motion of intent to annex additional land located at Woodland Hills, in Harlan County, Kentucky which land proposed to be annexed is described as follows:

Beginning at a point on the dividing ridge between the left-hand fork and the right-hand fork of the Dave Smith Branch in and near the Woodland Hills Subdivision at Tway and said point being in the existing corporate limits of the City of Harlan, said point being located on the 1600 foot contour; thence, leaving the existing corporate limits and running with the 1600 foot contour elevation, Northwardly and Westwardly approximately 4100 feet to the center of the ridge dividing the Dave Smith Branch and King Hollow, and said point being at the 1600 foot contour elevation; thence, running Southwardly down the ridge approximately 1000 feet to the existing corporate limits, thence with the existing corporate limits back to the beginning.

Whereas, the above described property is adjoining and adjacent to the boundaries of the City of Harlan at this time and the property is being developed as a sub-division for residential housing use, is urban in character or is suitable for development for urban proposes without unreasonable delay;

Whereas, the above described property is not included within the boundary of another incorporated city;

Whereas, all of the owners of record of all the land contained

in the above described property have given their prior consent in writing to the annexation;

Whereas, pursuant to KRS 81A.492 the City may enact a single ordinance annexing the land described in the Ordinance when it obtains the prior written consent of each owner of record of the land to be annexed;

Therefore, be it ordained by the City of Harlan that,
Section I: The above described property herein is annexed within the corporate limits of the City of Harlan, Kentucky
Section II: This ordinance shall take effect after its passage and upon publication.
