## AN ORDINANCE ANNEXING TERRITORY INTO THE CITY OF HARLAN THAT IS CONTIGUOUS WITH THE BOUNDARY OF THE CITY OF HARLAN AND LOCATED AT BAXTER, KY.

WHEREAS, the territory annexed, 0.347 acres in total, is contiguous to the City of Harlan, Kentucky and of urban character or suitable for urban development without unreasonable delay; and WHEREAS, the sole land owner(s) with the territory to be annexed has/have petitioned for the annexation of said territory with the City of Harlan, Kentucky and has/have signed a Request for Annexation of Privately Owned Territory in an effort to accomplish the same, WHEREAS, the City Council for the City of Harlan having by vote declared the territory desirous for annexation and acknowledge the suitable character and nature of the territory to be annexed in accordance with Ky. Rev. Stat. Ann. 81A.420.

NOW, THEREFORE, BE IT ORDAINED by the City of Harlan, Commonwealth of Kentucky;

1. The territory described below, a map of which is attached to this ordinance as Exhibit A and is fully incorporated into this ordinance as if set out in its entirety herein, is hereby annexed into the City of Harlan, Kentucky:

## **DESCRIPTION OF LAND**

Beginning at a point in the existing City of Harlan Corporate Boundary, said point being in the East Right of Way of US 421, and the North right of way of Hillside Dr., CR 1318B1, at Latitude 36.85581d, Longitude -83.32350d; thence, running Eastwardly with the North right of way of Hillside Dr., CR 1318B1 to a point with Latitude 36.85580d, Longitude -83.323130d; thence, leaving Hillside Dr, CR 1318B1, and running North to a point in the South right of way of Kerns Dr, CR1318A8, with Latitude 36.856058d, Longitude -83.32316d.; thence, running with the South right of way of Kerns Dr., CR1318A8 to a point with Latitude 36.85617d, Longitude -83.32341d; thence, leaving Kerns Dr., CR1318A8, and running West to a point in the East Right of Way of US 421, and having a Latitude 36.85614d, Longitude -83.32366d, said point in the existing City of Harlan Corporate Boundary line; thence, running Southwardly with the East right of way of US 421, and the existing City of Harlan Corporate Boundary line to the point of Beginning, containing approximately 0.347 acres.

- 2. That any Ordinance, Executive Order, Municipal Order, or adopted Policies in conflict with this Ordinance are hereby repealed in so far as the same are in conflict herewith.
- 3. That any Ordinance, Executive Order, Municipal Order, or Adopted Policies so repealed by the provisions of Section 3, above, shall be repealed in a manner and fashion as to save what portion(s) of the repealed provision are not in direct conflict with the instant Ordinance
- 4. That this Ordinance shall be in full force and effect upon passage, approval and publication according to law.
