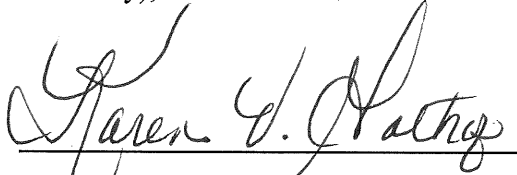

ORDINANCE NO. 2010-11

AN ORDINANCE ANNEXING UNINCORPORATED TERRITORY ADJOINING THE CITY OF HILLVIEW, BULLITT COUNTY, KENTUCKY.

The City Council of the City of Hillview, Bullitt County, Kentucky, does hereby ordain as follows:

SECTION I: The City Council of the City of Hillview, Bullitt County, Kentucky, does hereby annex certain unincorporated territory to the City of Hillview, Bullitt County, Kentucky, and such territory shall become a part of the City for all purposes under the laws of the Commonwealth of Kentucky, and such territory annexed is described as follows:

Beginning at a point in the current boundary of the City of Hillview as established in City of Hillview Ordinance #2008-14 in the north right of way of Brooks Schoolhouse Road, approximately 2100' from the intersection of the north right-of-way of Brooks Schoolhouse Road and the west right-of-way of Ky. Hwy. #1020; thence leaving the north right-of-way of Brooks Schoolhouse Road and crossing over a curve in the road S 59° 19' 25" W, a distance of 120.21' to a point in the east right-of-way of Brooks Schoolhouse Road; thence continuing with said right-of-way S 30° 56' 38" W, a distance of 59.31' to a point; thence S 08° 28' 36" W, a distance of 69.52' to a point; thence S 05° 07' 29" W, a distance of 2340.14' to a point; thence S 05° 15' 53" W, a distance of 355.46' to a point; thence S 04° 58' 16" W, a distance of 1373.94' to a point at the intersection of the east right-of-way of Brooks Schoolhouse Road with the north right-of-way of Ky. Hwy. #1516 (Brooks Hill Road); thence with the north right-of-way of Ky. Hwy. #1516 (Brooks Hill Road) S 87° 09' 56" E, a distance of 117.31' to a point; thence S 77° 19' 32" E, a distance of 162.30' to a point; thence S 66° 01' 35" E, a distance of 809.64' to an iron pin & cap (PLS #3334) in the north right-of-way of Ky. Hwy #1516 (Brooks Hill Road); at the southwest corner of a 16.00 acre tract conveyed to the Bullitt County Board of Education in DB 729/PG 676 dated 12/23/2008; thence leaving said right-of-way with said west line of 16.00 acre tract N 10° 43' 25" E (for N 09° 54' 52" E), a distance of 915.15' to an iron pin & cap (PLS #3334); thence S 87° 46' 59" E, (for S 88° 35' 32" E) a distance of 596.93' to an iron pin & cap (PLS #3334); in the west line of tract conveyed to Tommy & Robin Freeman in DB 278 PG 32; thence with line of Freeman S 02° 13' 01" W (for S 01° 24' 28" W), a distance of 222.04' to a stone; at the northwest corner of another tract conveyed to Freeman in DB 440 PG 65; thence S 03° 18' 33" W, (for S 02° 30' 00" W) a distance of 332.79' to a stone; at the northwest corner of second tract conveyed to Joyce Ann Trammell in DB 267/PG 807;

thence with line of Trammell S 05° 28' 17" W, (for S04° 39' 44" W) a distance of 644.95' to a 1/2" rebar in the north right-of-way of Ky. Hwy. #1516 (Brooks Hill Road); at the southwest corner of tract conveyed to James S. Meniffee & Wilma Meniffee in DB 201/PG 436; thence crossing over said road S 05° 28' 17" W, a distance of 63.97' to a point on in the south right-of-way of line of Ky. Hwy. #1516 (Brooks Hill Road); thence with the south right-of-way of Ky. Hwy. #1516 (Brooks Hill Road) N 64° 13' 56" W, a distance of 483.07' to a point; thence N 65° 29' 08" W, a distance of 286.84' to a point; thence N 66° 01' 35" W, a distance of 803.43' to a point; thence N 77° 19' 32" W, a distance of 151.20' to a point; thence N 87° 09' 56" W, a distance of 154.41' to a point; thence crossing over Ky. Hwy. #1516 (Brooks Hill Road) N 04° 58' 16" E, a distance of 60.04' to a point at the intersection of the north right-of-way of Ky. Hwy. #1516 (Brooks Hill Road) and the west right-of-way of Brooks Schoolhouse Road; thence with the west right-of-way of Brooks Schoolhouse Road N 04° 58' 16" E, a distance of 1375.53' to a point; thence N 05° 15' 53" E, a distance of 355.51' to a point; thence N 05° 07' 29" E, a distance of 2341.26' to a point; thence N 08° 28' 36" E, a distance of 78.63' to a point; thence N 30° 56' 38" E, a distance of 77.37' to a point; thence N 59° 19' 25" E, a distance of 72.52' to a point in the boundary of the City of Hillview as established in City of Hillview Ordinance #2008-14; thence with the same S 85° 59' 38" E, a distance of 70.30' to the point of beginning. Containing 22.55 acres, plus or minus.

SECTION II: This Ordinance shall be published according to law.

SECTION III: This Ordinance is enacted pursuant to KRS 81A.400, et.seq

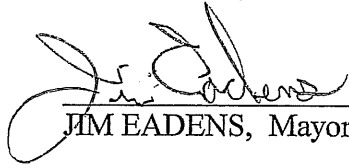
SECTION IV: This property having been proposed to be annexed by Ordinance No. 2010-02 and the sixty (60) day period having expired and no property owner of the real property pursuant to KRS 81A.420 within the limits of the territory proposed to be annexed filing a petition with the Mayor requesting this issue be placed on the ballot the City does hereby annex the above described property.

SECTION V: Any ordinance or part of ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.

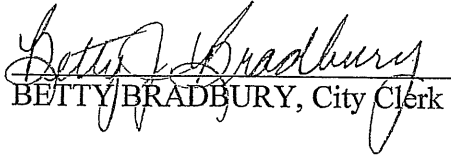
