

ORDINANCE NO. 2011-12

AN ORDINANCE ANNEXING UNINCORPORATED TERRITORY ADJOINING THE CITY OF HILLVIEW, BULLITT COUNTY, KENTUCKY.

The City Council of the City of Hillview, Bullitt County, Kentucky, does hereby ordain as follows:

SECTION I: The City Council of the City of Hillview, Bullitt County, Kentucky, does hereby annex certain unincorporated territory to the City of Hillview, Bullitt County, Kentucky, and such territory shall become a part of the City for all purposes under the laws of the Commonwealth of Kentucky, and such territory annexed is described as follows:

Beginning at a point in the current north boundary of the City of Hillview as established by City of Hillview Ordinance No. 90-10 where said boundary intersects the east right of way of East Blue Lick Road, thence with the east right of way East Blue Lick Road N 22° 40' 00" W 143.80' to a point, thence N 15° 48' 04" W 301.64 to a point, thence S 78° 13' 06" E 297.62' with the north right of way of Velva Drive to a point, thence N 11° 12' 32" E 107.73' to a point, thence N 11° 10' 21" E 154.27' to a point in the Bullitt/Jefferson County line, thence with the Bullitt/Jefferson County line, N 84° 48' 00" W 170.65' to a point, thence N 85° 31' 40" W 50.59' to a point, thence N 85° 13' 15" W 247.59' to the east right of way of East Blue Lick Road, thence N 89° 01' 07" W crossing East Blue Lick Road 351.70' to a point in the east right of way of Interstate 65, thence with the east right of way of Interstate 65 S 03° 06' 00" E 331.00' to a point, thence S 02° 53' 26" E 220.90' to a point in the northwest corner of LA Wholesale, Inc. (Deed Book 677 Page 659), thence with the north property line of LA Wholesale, Inc. N 88° 00' 00" E 470.00' to a stone in the west right of way of East Blue Lick Road, thence with the west right of way of East Blue Lick Road S 22° 40' 00" E 143.80' to a point in the north boundary of the City of Hillview as established in City of Hillview Ordinance No. 90-10, thence with the north boundary of the City of Hillview as established in City of Hillview Ordinance No. 90-10 N 87° 55' 28" E 60.00' to the point of beginning.

SECTION II: The City Council of the City of Hillview, Bullitt County, Kentucky, does find the property described above is of an urban character which is suitable for development purposes without unreasonable delay and does hereby declare it desirable to annex into the City of Hillview.

SECTION III: This property having been proposed to be annexed by Ordinance No. 2011-04, the owner of the real estate, according to the records maintained in the office of the Bullitt County Property Valuation Administrator, being Ken Hester and his wife Carol Hester and Kenneth T. Hester and his wife Carol Hester, have been provided written notice of the proposed annexation on August 5, 2011, and no owner and/or register voter and/or resident

having filed a petition with the Mayor requesting this issue be place on the next regular election ballot within sixty (60) days as required by KRS 81A.420, the City of Hillview may proceed.

SECTION IV: This Ordinance shall be published according to law.


SECTION V: This Ordinance is enacted pursuant to KRS 81A.400, et.seq.

SECTION VII: Should any section, clause, line, paragraph or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of the Ordinance.
