AN ORDINANCE ANNEXING UNINCORPORATED TERRITORY ADJOINING THE CITY OF HILLVIEW, BULLITT COUNTY, KENTUCKY.

The City Council of the City of Hillview, Bullitt County, Kentucky, does hereby ordain as follows:

SECTION I: The City Council of the City of Hillview, Bullitt County, Kentucky, does hereby annex certain unincorporated territory to the City of Hillview, Bullitt County, Kentucky, and such territory shall become a part of the City for all purposes under the laws of the Commonwealth of Kentucky, and such territory annexed is described as follows:

BEGINNING at a 1/2" iron pin and cap "JWA" in the northwest corner of Andy's Properties, LLC, which is the current boundary of the City of Hillview as annexed in City of Hillview Ordinance No. 99-17 in the east right way of I-65, thence with the east right of way of I-65, N 03° 30' 42" W 780' to a 5/8" rebar with cap PLS 2373, thence N 03° 30' 42" W 588.12" to a 5/8" rebar with cap PLS 2373, thence S 76° 27' 20" E 565.43' to the west right of way of Triangle Lane, thence with the east right of way of Triangle Lane S 22° 00' 24" W 565.83' to a 5/8" rebar with cap PLS 2373, thence N 76° 56' 00" W 309.67' to the point of beginning containing 5.635 acres.

SECTION II: The City Council of the City of Hillview, Bullitt County, Kentucky, does find the property described above is of an urban character which is suitable for development purposes without unreasonable delay and does hereby declare it desirable to annex into the City of Hillview.

SECTION III: The Mayor of the City of Hillview, Bullitt County, Kentucky, having received prior written consent of each owner of record of the land herein before described requesting annexation into the City of Hillview, and no resident voters who oppose annexation existing in this area, and all provisions of KRS 81A.412 having been complied with, the herein before described property is annexed into the City of Hillview, Bullitt County, Kentucky.

SECTION IV: This Ordinance shall be published according to law.


SECTION V: This Ordinance is enacted pursuant to KRS 81A.400, et seq.

SECTION VI: Any ordinance or part of ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.



AN ORDINANCE ANNEXING UNINCORPORATED TERRITORY ADJOINING THE CITY OF HILLVIEW, BULLITT COUNTY, KENTUCKY.

The City Council of the City of Hillview, Bullitt County, Kentucky, does hereby ordain as follows:

SECTION I: The City Council of the City of Hillview, Bullitt County, Kentucky, does hereby annex certain unincorporated territory to the City of Hillview, Bullitt County, Kentucky, and such territory shall become a part of the City for all purposes under the laws of the Commonwealth of Kentucky, and such territory annexed is described as follows:

BEGINNING at an iron pin said pin being located in southeast corner of Tract Two of annexation Ordinance of the City of Hillview Number 2003-07, thence with the current boundary of the City of Hillview N 00° 15' 19" E 177.80' (for N 00° 15' W 177.38') to a white oak, thence N 17° 36' 33" E 59.75' (for N 17° 45' E 60.72') to a white oak, thence N 31° 21' 57" E 322.60' (for N 31° 30' E 324.72') to a white oak, thence N 33° 00' 00" E 33.00' (for N 30° 00' E 33.00') to a 5/8" rebar with cap PLS 2373, thence S 83° 56' 44" E 31.55' to a pipe, thence S 01° 57' 14" W 133.27' to a pipe, thence S 75° 33' 42" E 337.95' to a concrete r of w monument, thence S 14° 08' 39" W 130.94' to a concrete r of w monument, thence S 21° 32' 44" E 210.60' to a concrete r of w monument, thence S 03° 29' 23" E 136.66' to a 5/8" rebar with cap PLS 2373, thence N 76° 56' 00" W 628.80' to the point of beginning containing 5.7384 acres.

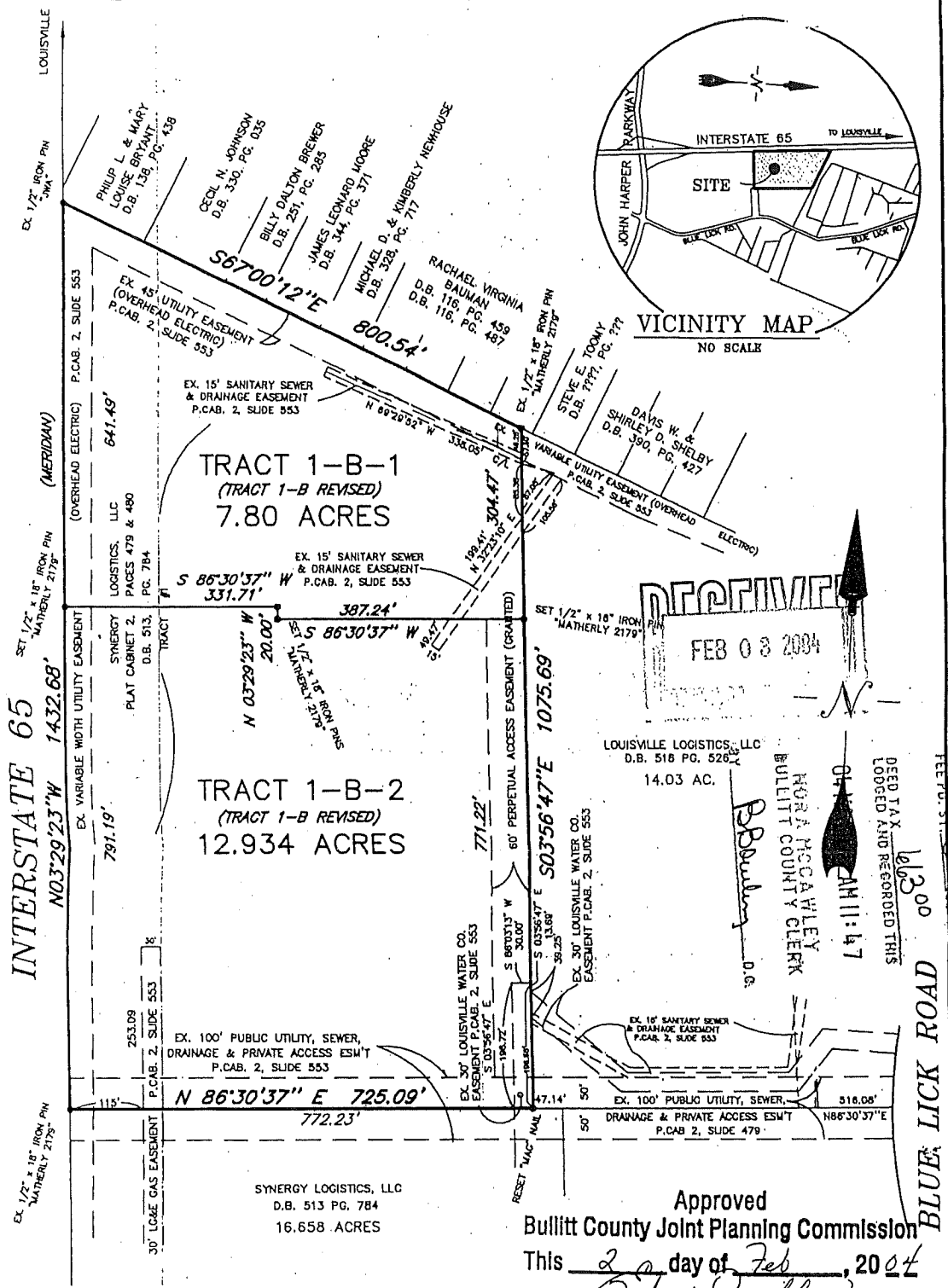

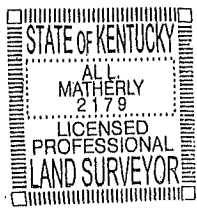
