

ORDINANCE NO. 87-21

AN ORDINANCE ANNEXING UNINCORPORATED TERRITORY ADJOINING THE CITY OF HILLVIEW, BULLITT COUNTY, KENTUCKY.

The City Council of the City of Hillview, Bullitt County, Kentucky, does hereby ordain as follows:

Section I: The City Council of the City of Hillview, Bullitt County, Kentucky, does hereby annex certain unincorporated territory to the City of Hillview, Bullitt County, Kentucky, and such territory shall become a part of the City for all purposes under the laws of the Commonwealth of Kentucky and such territory annexed is described as follows:

BEGINNING at a point in the West right of way of Blue Lick Road, said point being South 23 degrees 12 minutes 41 seconds West 50.90 feet from the iron pin at the Northeast corner of Tract 2 of the S. B. Williams, Jr. and Pauline Williams property as shown by survey of H. B. Sedoris, Jr. dated November 24, 1986; thence South 23 degrees 12 minutes 41 seconds West 103.06 feet; thence North 66 degrees 18 minutes 27 seconds West 152.70 feet to a corner post; thence North 23 degrees 41 minutes 32 seconds East 103.06 feet to a corner post; thence South 66 degrees 18 minutes 28 seconds East 151.83 feet to the point of beginning, containing 0.36 acres as shown by survey of H. B. Sedoris, Jr. dated November 24, 1986.

Section II: This Ordinance shall be published according to law.

Section III: This Ordinance is enacted pursuant to KRS 81A.400 et.seq.


Section IV: This property having been proposed to be annexed in Ordinance No. 87-12 and the required sixty (60) days having expired on the 28th day of September, 1987 and fifty per cent (50%) of the resident voters or owners of real property within the limits of the territory proposed to be annexed not having petitioned the Mayor requesting this issue to be placed on the ballot, the City does hereby annex the above described property.

Section V: Any ordinance or part of ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.

Section VI: Should any section, clause, line, paragraph or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.

Given first reading in a regular meeting of the City Council of the City of Hillview, Bullitt County, Kentucky, on the 19th day of October, 1987. Given second reading, voted upon, and passed at a regular meeting of the City Council of the City of Hillview, Bullitt County, Kentucky, on the 29th day of October, 1987.
