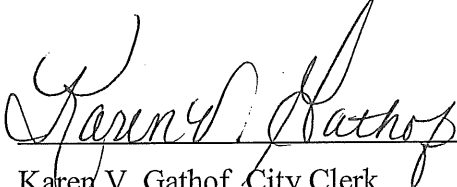

ORDINANCE NO. 89-10

AN ORDINANCE ANNEXING UNINCORPORATED TERRITORY ADJOINING THE CITY OF HILLVIEW, BULLITT COUNTY, KENTUCKY. *PINK STAMP*

The City Council of the City of Hillview, Bullitt County, Kentucky, does hereby ordain as follows:

SECTION I: The City Council of the City of Hillview, Bullitt County, Kentucky, does hereby annex certain unincorporated territory to the City of Hillview, Bullitt County, Kentucky, and such territory shall become a part of the City for all purposes under the laws of the Commonwealth of Kentucky, and such territory annexed is described as follows:

Commencing at a steel fence post at the intersection of the east right-of-way of Brooks Hill Road and the north right-of-way of Blue Lick Road; thence S. 52 degs. 45' 03" E. 24.95 ft. to a concrete right-of-way marker in the north line of Blue Lick Road; thence S. 89 degs. 56' 16" E. 38.86 ft. to an iron pin; thence on an arc to the north, the chord line being S. 78 degs. 43' 18" E.; 249.28 ft. (radius 766.57 ft. & arc=250.39 ft.) to an iron pin in line of Blue Lick Road; thence N. 20 degs. 38' 09" E. 186.36 ft. to an iron pin in the south right-of-way line of Brooks Hill Road; thence N. 61 degs 36' 33" W. 118.31 feet to an iron pin; thence S. 57 degs. 40' 36" W. 312.68 feet to the point of beginning and containing 1.00 acre as shown by survey of Maxie Armstrong dated November 18, 1988.

SECTION II: The Ordinance shall be published according to law.

SECTION III: This Ordinance is enacted pursuant to KRS 81A.400, et. seq.

SECTION IV: This property having been proposed to be annexed by Ordinance No. 89-03 and the sixty (60) day period having expired and no property owner or registered voter of the real property within the limits of the territory proposed to be annexed filing to petition with the Mayor requesting this issue be placed on the ballot, the City does hereby annex the above described property.

SECTION V: Any ordinance or part of ordinance in conflict with this Ordinance or any part of this Ordinance is hereby repealed.

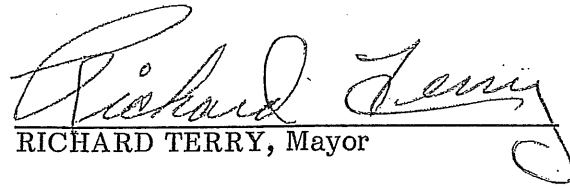
