ORDINANCE NO. 20-90

AN ORDINANCE ANNEXING TERRITORY INTO  
THE CITY OF HOPKINSVILLE, KENTUCKY

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF  
HOPKINSVILLE, KENTUCKY, AS FOLLOWS:

SECTION ONE

The City Council does hereby declare an area described in  
Exhibit A to be annexed into the City limits of Hopkinsville.  
Exhibit A is attached hereto and incorporated herein by the  
reference as if fully set forth.

SECTION TWO

The City Council does hereby declare that an Ordinance of  
Intent No. 12-90 was adopted pursuant to KRS 81A.420 and pub-  
lished pursuant to KRS 424.130 and 424.140 on the 14th day of  
September, 1990, and as stipulated in KRS 81A.412, the affected  
property owners have waived the 60-day remonstrance period and  
requested to be annexed into the City of Hopkinsville.

SECTION THREE

The City Council declares that City taxes will be in effect  
on the 1st day after publication of this ordinance.

SECTION FOUR

Any and all existing ordinances inconsistent with this ordi-  
nance are repealed.

SECTION FIVE

If any section, subsection, sentence, clause, phrase or  
portion of this ordinance is for any reason held invalid or  
unconstitutional by any court of competent jurisdiction, such  
portion shall be deemed a separate, distinct and independent  
provision and such holding shall not affect the validity of the  
remaining portions thereof.

SECTION SIX

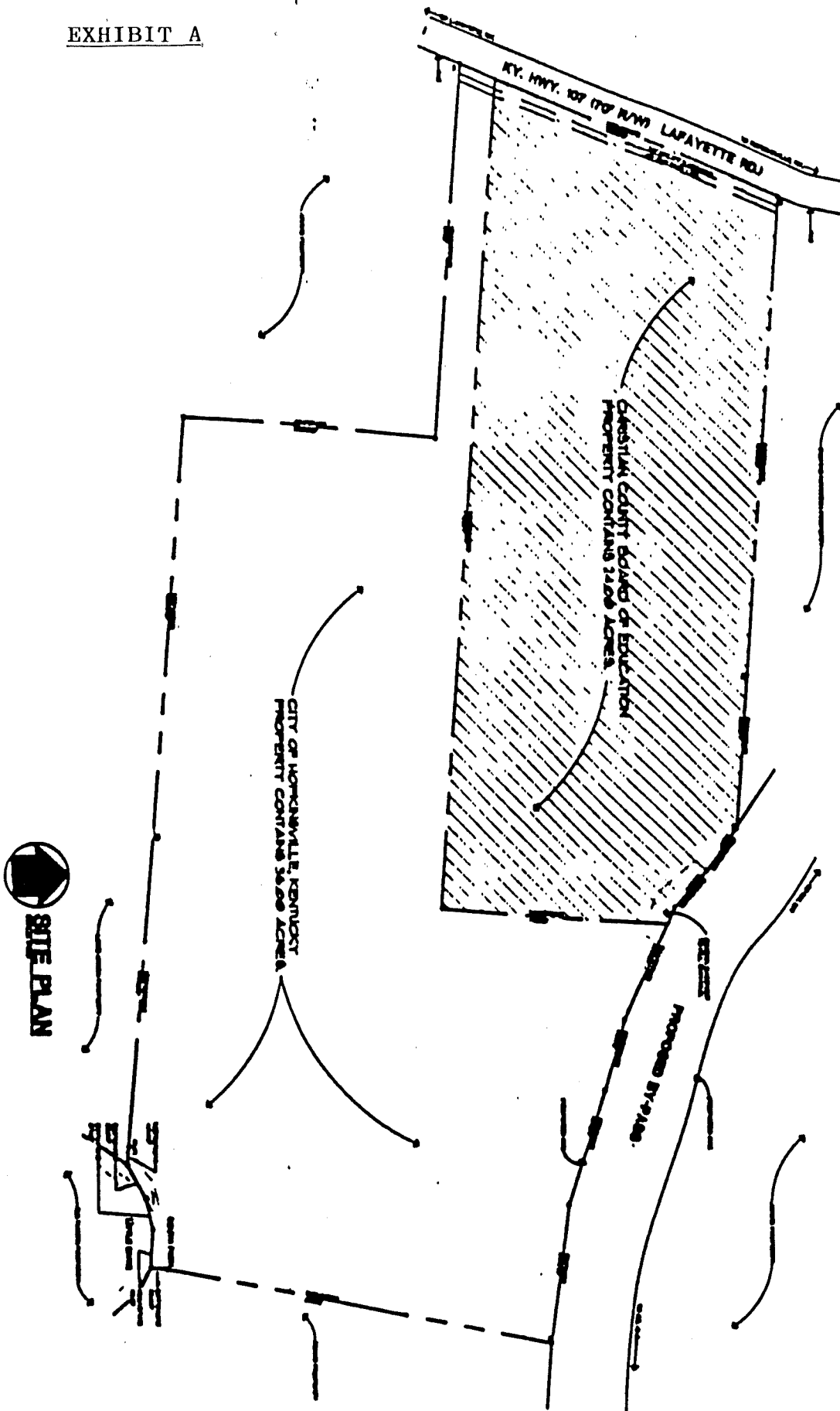
This ordinance shall take effect immediately after passage and publication according to law.
