ORDINANCE 04-2010

AN ORDINANCE ANNEXING TERRITORY INTO THE CITY OF HOPKINSVILLE, KENTUCKY (61.301 Acres – Eagle Way Area)

WHEREAS, the property owners of record of the land to be annexed, Eagle Way Church of Christ, Southern States Hopkinsville Petroleum Cooperative, Inc., Ag Spray Equipment, Inc., and H&R Agri-Power, Inc., have given prior written consent to annexation of the property; and

WHEREAS, a Consent to Annexation, Release and Restrictive Covenant form for Eagle Way Church of Christ is on file in MS Book 102, page 469 at the Christian County Courthouse; and

WHEREAS, a Consent to Annexation, Release and Restrictive Covenant form for Southern States Hopkinsville Petroleum Cooperative, Inc., is on file in MS Book 83, page 21 at the Christian County Courthouse; and

WHEREAS, a Deed Restriction seeking annexation by Ag Spray Equipment Inc., is on file in MS Book 60, page 693 at the Christian County Courthouse; and

WHEREAS, a Deed Restriction seeking annexation by H&R Agri-Power, Inc., is on file in MS Book 62, page 618 at the Christian County Courthouse.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HOPKINSVILLE, AS FOLLOWS:

SECTION ONE

Pursuant to KRS 81A.412 Hopkinsville City Council hereby annexes the following unincorporated area of Christian County into the City limits of Hopkinsville:

A portion of land consisting of approximately 61.301 acres, known as Eagle Way Area, adjacent to current City limits as more particularly described in Exhibit A which is attached hereto and incorporated herein by reference as if fully set forth.

Hopkinsville City Council hereby declares the service delivery plan and City taxes will be in effect on the first day after publication and notice as required in KRS 81A.470 and KRS 81A.475 have been met.

SECTION TWO

If any section, subsection, sentence, clause, or phrase of this ordinance is held unconstitutional or otherwise invalid, such infirmities shall not affect the validity of the remaining portions of this ordinance.

SECTION THREE

Any and all existing ordinances inconsistent with this ordinance are repealed.


SECTION FOUR

This ordinance shall take effect after its passage and publication according to law.


