

ORDINANCE 2011-14

AN ORDINANCE ANNEXING PROPERTY

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HORSE CAVE, KENTUCKY, AS FOLLOWS:

Section 1. That on or about August 1, 2011, the CITY OF HORSE CAVE acquired certain real property located in Hart County, and as the owner of said property consents to the annexation set for herein; and

Section 2. The real property, as more particularly described below, be and the same is hereby annexed into the CITY OF HORSE CAVE:

PARCEL I: Being Lot 1 and more particularly described as follows: Beginning at a stake at the East intersection of the said drive; thence N. 9E 158 ft. to a stake corner to Lot #2; thence South 84 East 200 ft. to a take in the Bale line; thence S 12 W 158 ft. to a stake at the North right-of-way of Hwy. 218; thence with the said Hwy. N 84 W 204 ft. to the point of beginning containing 0.73 acre more or less, according to actually survey of October 8, 1984, by Bobbie Blakeman.

PARCELL II: Being Lot 2 and more particularly described as follows: Beginning at a stake on the East side of said drive and corner to Lot #1; thence N 9 E 270 ft. to a stake corner to Lot #3; thence S 84 E 195 ft. to a stake in the Bale line; thence S 12 W 270 ft. to a stake corner to Lot #1; thence N 84 W 200 ft. to the point of beginning containing 1.22 acres, more or less, according to actual survey of October 8, 1984, by Bobbie Blakeman.

A plat of the above described property is duly recorded in Plat Book 2, Page 17, Office of the Hart County Clerk.

Being the same property conveyed to the City of Horse Cave by Deed from Paul D. Waddle and Rosann Waddle, husband and wife, said Deed dated August 1, 2011, duly recorded in Deed Book 310 Page 353, Office of the Hart County Clerk.

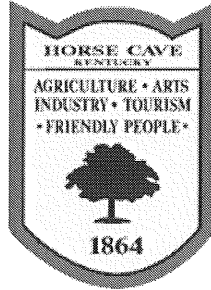
