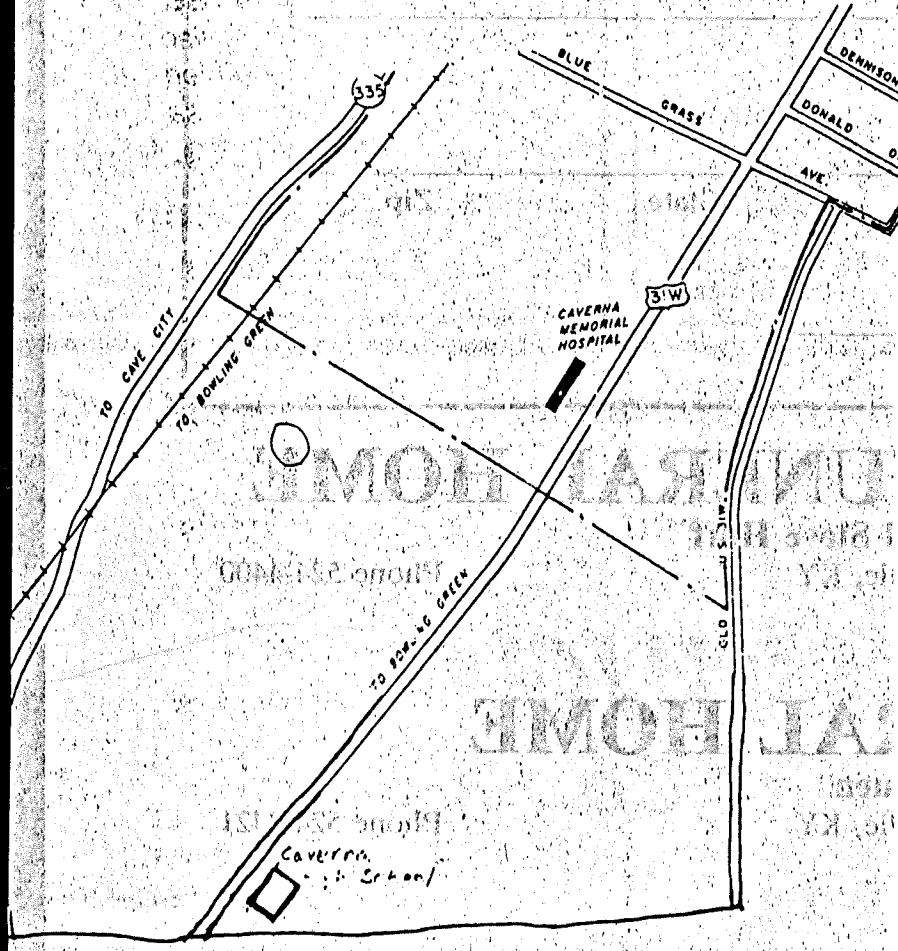

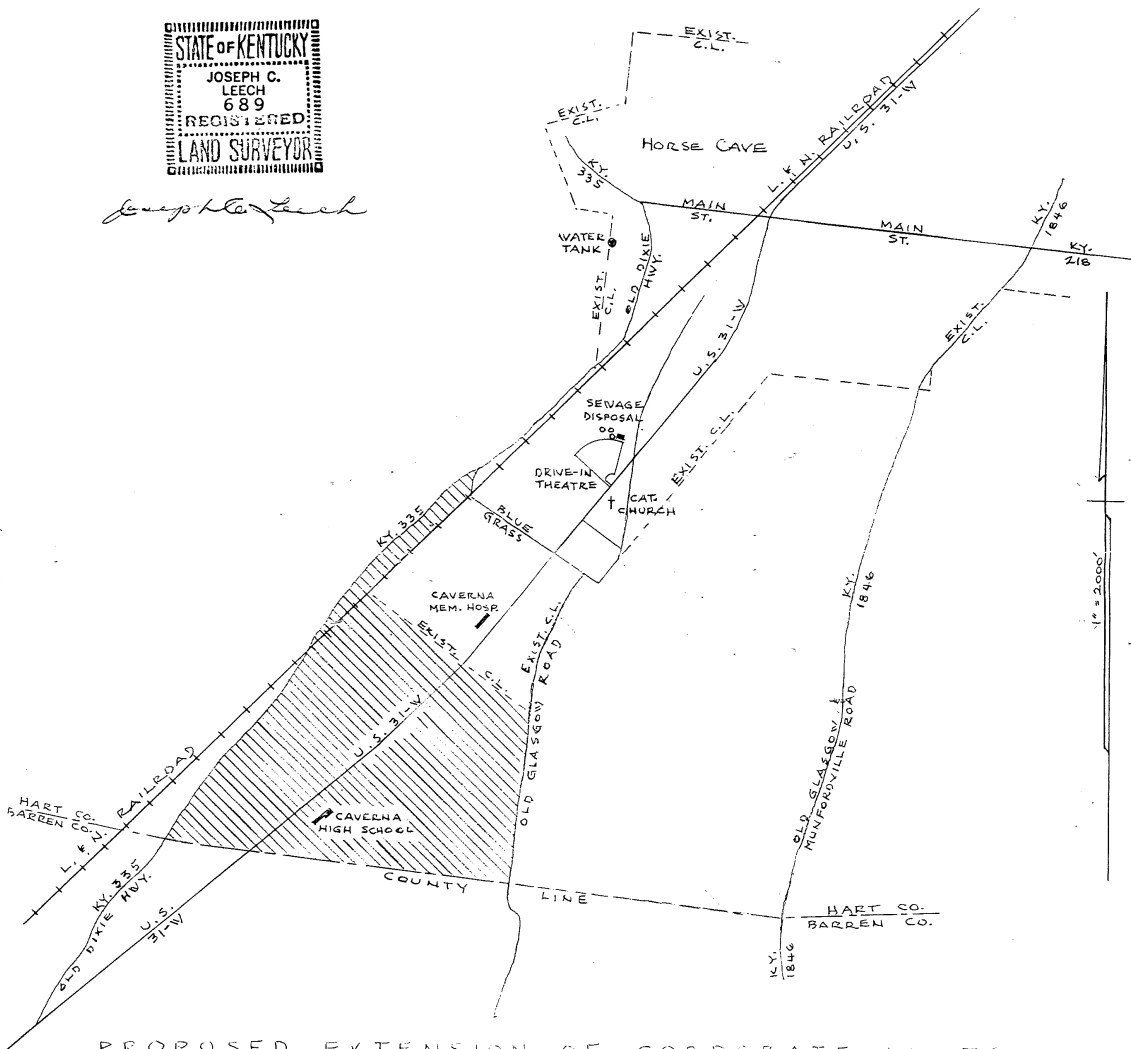
DESCRIPTION OF PROPOSED EXTENSION OF CORPORATE LIMITS AND ANNEXATION OF ADDITIONAL TERRITORY TO THE CITY OF HORSE CAVE, HART COUNTY, KY.:

BEGINNING at a point in the center of the old Dixie Highway, now Ky. 335, at the existing Corporate Limits line at the intersection of said Highway and Blue Grass Avenue, about 2,000 feet west of the Drive-In Theatre screen; running thence with the centerline of Ky. 335, the Old Dixie Highway, and with the meanders of same, in a southwest direction, about 8,000 feet to the Barren and Hart County line; thence with said County line, in an eastward direction, about 5,500 feet to a point in the center of the old Glasgow Road; thence northwardly with the meanders of the centerline of the old Glasgow Road, about 2,800 feet to the existing Corporate Limits line; thence with existing Corporate Limits line, northwestwardly, and northeastwardly to the beginning.
