ORDINANCE NO. 1-9-81

AN ORDINANCE ANNEXING TO THE CITY OF INDEPENDENCE THE TERRITORY GENERALLY BOUNDED BY COX ROAD, FOWLER CREEK ROAD, SENOUR ROAD AND KENTUCKY 16.

BE IT ORDAINED BY THE CITY OF INDEPENDENCE:

SECTION I

The City of Independence does hereby annex to the City the following described territory:

Beginning at the intersection of Cox Road and Kentucky 16 at the boundaries of the City of Independence; thence generally westwardly along the south right-of-way line of Cox Road to its intersection with the west right-of-way of Fowler Creek Road; thence northwardly along the west right-of-way line of Fowler Creek Road to its intersection with Senour Road; thence generally eastwardly along the north right-of-way line of Senour Road to its intersection with Kentucky 16's eastern right-of-way; thence southwardly along the east right-of-way of Kentucky 16 to its intersection with Cox Road; thence to the point of beginning.

SECTION II

There is excluded herefrom any area already in any incorporated City, including the City of Independence.

SECTION III

This Ordinance shall become effective immediately.

ORDINANCE NO. 2-9-81

AN ORDINANCE ANNEXING TO THE CITY OF INDEPENDENCE
TERRITORY GENERALLY BOUNDED BY INDUSTRIAL ROAD,
THE BOONE COUNTY LINE, RICHARDSON ROAD AND
TURKEYFOOT ROAD.

BE IT ORDAINED BY THE CITY OF INDEPENDENCE:

SECTION I

The City of Independence does hereby annex to the City the following
described territory:

Beginning at a point in the south right-of-way line at
Richardson Road extended near the Beechgrove School
sometimes referred to as Turkeyfoot Road at this point;
thence continuing generally westwardly along the south
right-of-way line of Richardson Road to the Boone County
line; thence generally northwardly along the Boone County
line to a point in the north right-of-way line of Industrial
Road; thence generally eastwardly along the north right-of-
way line of Industrial Road to a point where it intersects
with the easterly right-of-way line of Turkeyfoot Road;
thence generally southwardly along the easterly right-of-way
line of Turkeyfoot Road to the point of beginning.

SECTION II

There is excluded herefrom any area previously annexed into the
City of Independence.

SECTION III

This Ordinance shall become effective immediately.
