#### **ORDINANCE NO. 1999-O-07**

AN ORDINANCE ANNEXING TO AND MAKING A PART OF THE INCORPORATED TERRITORY OF THE CITY OF INDEPENDENCE, KENTUCKY, CERTAIN UNINCORPORATED TERRITORY LYING CONTIGUOUS AND ADJACENT TO THE CITY OF INDEPENDENCE.

WHEREAS, the City Council has received oral and written requests from Wayne H. Ferguson and Karen S. Ferguson and otherwise deems it to be in the best interests of its citizens as well as those residing in certain unincorporated territory, said territory being contiguous and adjacent to the present city limits, that said territory be annexed to and become part of the incorporated territory of the City.

WHEREAS, all of the requirements of K.R.S. 81A.412 are met and all concerned property owners have manifested their consent.

NOW, THEREFORE, the City Council of the City of Independence, Kentucky, does ordain as follows:

## **SECTION I**

That it is hereby enacted that the hereinafter describe unincorporated territory lying contiguous and adjacent to the present city limits of the City of Independence, Kentucky is annexed and made a part of the incorporated territory of the City of Independence, Kentucky.

## **SECTION II**

Said territory hereby annexed is bound and described as follows, to wit:

A parcel of ground lying and being in Sunshine Subdivision in Independence in Kenton County, Kentucky and more particularly described as follows:

Beginning at a iron pin in the South Right of Way of Pelly Road and said point being the Northwest corner of Lot #37 of Sunshine Subdivision as recorded in Plat Book 6, Page 17; thence with a line partitioning Lot #37 & #38, S 47° 19' E-145.03 feet to a iron pin in the rear line of said subdivision and also being 3.00 feet Southwest of the Southwest corner of Lot #37; thence with the rear line of said subdivision, N 41° 30'E-140.0 feet to a iron pin; thence with a line partitioning Lot #32, N 48° 30'W-145.0 feet to a iron pin in the R/W of Pelly Road and said point being 13.00 feet Southwest of the Northwest corner of Lot #31; thence with the R/W of said road S.41° 30' W – 137.00 feet to the place of beginning containing 20083 square foot. 17; thence with the right of way of said road S. 41° 30' W. 138.00 feet to an iron pin, said point being 13 feet southwest of Lot No. 32; thence with a line partitioning Lot No. 32, S. 48° 30' E. 145.00 feet to an iron pin being 13.0 feet southwest of Lot No. 32; thence with the rear line at said subdivision N 41° 30'E 138.00 feet to an iron pin being the southeast corner of Lot No. 27; thence with the East line of said lot, N.48° 30' W. 145.00 feet to the place of beginning, containing 20,010 square feet. Said property being currently owned by Wayne H. Ferguson and Karen S. Ferguson.

## **SECTION III**

This ordinance shall be in full force and effect from and after its publication as required by law.

### **SECTION IV**

All ordinances, resolutions, minutes and meetings, or parts thereof, in conflict herewith, are to the extent of such conflict, hereby repealed.

## **SECTION V**

If any section, paragraph or clause of this ordinance be held by a proper court to be invalid, such invalidity shall not effect the remaining sections, paragraphs or clauses, it being expressly declared that the remainder of said ordinance would have been passed despite such invalidity.
