ORDINANCE NO. 2004-O-17

AN ORDINANCE OF THE CITY OF INDEPENDENCE, IN KENTON COUNTY, KENTUCKY, ANNEXING THE MULLINS/FREEDOM PARK, LLC PROPERTY CONSISTING OF APPROXIMATELY 56 ACRES, WHICH PROPERTY IS THE SUBJECT OF A REZONING IN ORDINANCE 2004-O-16.

WHEREAS, Freedom Park, LLC, owner by contract, and Margaret Mullins, property owner (hereinafter "OWNERS"), have requested the City of Independence to annex and zone the Margaret Mullins property located at 11527 Wilson Road, Independence, Kentucky (approximately 56 acres), pursuant to KRS 100.209 and KRS 81A.412;

WHEREAS, on Monday, June 7th, the City Council of the City of Independence voted unanimously to proceed with a voluntary annexation/zoning of the aforesaid Margaret Mullins property;

WHEREAS, the Kenton County & Municipal Planning & Zoning Commission has held a public hearing and made its recommendation, and the City of Independence has adopted Ordinance 2004-O-16, thereby rezoning the property; and

WHEREAS, The City of Independence hereby declares it desirable to annex the unincorporated territory to the City.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF INDEPENDENCE, IN KENTON COUNTY, KENTUCKY, AS FOLLOWS:

- <u>Section 1.</u> The unincorporated territory which is the subject of this Ordinance, is approximately 56 acres of property owned by the Margaret Mullins, under contract to Freedom Park, LLC, and is located at 11527 Wilson Road, Independence, Kentucky.
- <u>Section 2.</u> The unincorporated territory which is the subject of this Ordinance is described in Exhibit 'A', and is illustrated in Exhibit 'B', both attached to this Ordinance. The Exhibits accurately define the boundary of the unincorporated territory proposed to be annexed.
- Section 3. The unincorporated territory which is the subject of this Ordinance in Exhibits 'A' and 'B', consists of approximately 56 acres of property, is contiguous to the City's boundaries at the time this annexation proceeding is begun and, by reason of present, potential or future population density, commercial, industrial, institutional, or governmental use of the land, or subdivision of land, is urban in character or suitable for development for urban purposes without unreasonable delay. The City hereby declares it desirable to annex the unincorporated territory. No part of the area to be annexed is included within the boundary of another incorporated city.
- Section 4. Since the owner of record of the land to be annexed has given prior consent in writing to the annexation, the City shall not be required to enact the notification ordinance required by KRS 81A.420 (1) or to comply with the notice requirements of KRS 81A.425, and it shall not be required to wait the sixty (60) day period provided for in KRS 81A.420 (2) prior to enacting a final ordinance annexing the area. Pursuant to KRS 81A.412, the City does hereby enact this single ordinance finally annexing the land described in this ordinance.

<u>Section 5.</u> The property which is the subject of this ordinance, consisting of 56 acres of property is hereby annexed into the City limits of the City of Independence, in Kenton County, Kentucky, for all purposes.

<u>Section 6.</u> The City has elected to follow the procedure provided for in KRS 100.209 (1), and has adopted Ordinance 2004-O-16 prior to the adoption of this Ordinance of Annexation, therefore the newly annexed territory shall be subject to the land use and other zoning restrictions as set forth in that Ordinance.

<u>Section 7.</u> This ordinance shall be effective upon its adoption and approval according to law, and publication thereafter.

<u>Section 8.</u> All ordinances or parts of any ordinances in conflict herewith, to the extent of the conflict, if any, are hereby repealed.

<u>Section 9.</u> The foregoing Ordinance was read, passed and adopted by the Council of the City of Independence, Kentucky, meeting in Regular Sessions on the 2nd day of August, 2004, and on the 13th day of September, 2004, with five (5) yes votes, one (1) no vote, and zero (0) abstentions, and was thereafter approved by the Mayor and ordered published in summary according to law.

Parcel to be annexed by the City of Independence

Beginning at a point in the center of Freedom Trail, Section Twelve, Freedom Park and in the existing City of Independence line; thence with the existing city limits and Freedom Park N 49° 48' 52" E, 207.17 to a point in the line with Hardbeck (DB 350, page 236) thence leaving the city limits of Independence and with Hardbeck N 67° 29' 19" W, 76.31 feet to a point; thence N 71° 33' W, 491.35 feet to a corner with Wagner (DB 147, page 401); thence with Wagner N 71° 17' 05" W, 898.38 feet to a corner with Easybuck (DB 144 & 149, page 506 & 664); thence with Easybuck N 69° 23' 19" W, 364.23 feet to a corner with Fite (DB 378, page 175); thence with Fite N 69° 22' 59" W, 86.96 feet to a point; thence S 18° 03' 08" W, 343.19 feet to corner with Farris (DB 779, page 34); thence with Farris S 19° 46' 12" W, 264.10 feet to a corner with Hammond (DB I1248, page 182); thence with Hammond S 16° 05' 58" E, 176.74 feet to a point; thence S 31° 08' 31" E, 219.47 feet to a corner with Leblang (DB 394, page 158) S 89° 32' 51" W, 498.95 feet to a point; thence N 83° 03' 24" W, 35.57 feet to a corner with Sharon (DB 99, page 335); thence with Sharon S 06° 22' 20" W, 114.79 feet to a point in the line with Schadler (DB 268, page 226); thence with Schadler S 81° 16' 41" E, 25.06 feet to a point; thence S 05° 48' 54" E, 154.46 feet to a corner with Cheesman (DB 391, page 289) thence with Cheesman S 05° 49' 35" E, 106.88 feet to a point; thence N 86° 16' 03" W, 235.49 feet to a point in the east right of way line Wilson Road; thence with the east right of way line S 03° 22' 08" E, 13.61 feet to a point; thence S 06° 52' 30" E, 384.12 feet to a point; thence S 07° 52' 47" E, 156.47 feet to a corner with Scott (I413, page 206); thence leaving said east right of way and with Scott S 86° 41' 35" E, 313.25 feet to a point; thence N 80° 35' 43" E, 469.43 feet to a point; thence S 42° 02' 48" E, 220.68 feet to a corner with Endres (DB 339, page 240) and in the line with Heckman (DB 102, page 343) thence with Heckman N 50° 33' 08" E, 1067.41 feet to a corner with the Freedom Park Subdivision and Lot 141 Section Twelve, said point also being in the existing line of the City of Independence; thence with Freedom Park Subdivision and the City of Independence N 49° 48' 52" E, 784.39 feet to the point of beginning. Containing 59.39 Acres.
