JUDGMENT

* * * * *

This cause coming on to be heard on Petition of the City of Jeffersontown, Kentucky, a city of the Fourth Class, and the exhibits thereto, including consent of the sole owner of the land sought to be annexed, and no remonstrance having been filed herein, and no order for granting future time for making defense having been entered herein; and this Court Finding that all requirements of K.R.S. 81.210 applicable to said annexation have been complied with,

IT IS HEREBY ORDERED AND ADJUDGED:

1. That a tract of land hereinafter described be, and hereby is, annexed to the corporate limits of the City of Jeffersontown, Kentucky, and that the city boundary of the City of Jeffersontown, Kentucky, is extended to include therein the following tract of land, to-wit:

BEGINNING at a point in the southerly boundary line of Centralia Subdivision of record in Deed Book 427, page 638 and Deed Book 434, page 640, at its intersection with the southerly right of way line of the Southern Railroad, said point being also in the existing city boundary line as established by Ordinance No. 216, Series 1956; thence with said line of Centralia Sub-division and the existing city boundary line, South 68

47 seconds East, 1,833.275 feet, more or less, to the northerly right of way line of Rehl Road; running thence with the northerly right of way line of Rehl Road, North 70 degrees 33 minutes 26 seconds East, 178.0 feet, more or less; North 63 degrees 01 minutes 20 seconds East, 158.17 feet, more or less; and North 67 degrees 07 minutes 20 seconds East, 119.6 feet, more or less, to a point in the easterly line of the tract conveyed to Butler aforesaid at its intersection with the northerly right of way line of Rehl Road; running thence with the easterly line of the aforementioned tract, North 28 degrees 40 minutes 23 seconds West, 461.42 feet, more or less; running thence South 70 degrees 49 minutes 02 seconds West, 74.395 feet, more or less; running thence North 27 degrees 22 minutes 36 seconds West, 933.405 feet, more or less, to a point in the westerly right of way line of Southern Railroad; running thence with the westerly right of way line of Southern Railroad, North 63 degrees 02 minutes 32 seconds West 222.15 feet, more or less; thence North 59 degrees 50 minutes 52 seconds West 121.53 feet, more or less; thence North 56 degrees 39 minutes 12 seconds West, 194.895 feet, more or less, to the point of beginning; being the same tract of land acquired by James J. Butler, Jr. by Deed of record in Deed Book 3449, page 474, less so much thereof as lies in the right of Rehl Road; being a portion of a tract presently owned by Winebrenner & Powers Investments, a Kentucky General Partnership, Deed dated April 10, 1978, Deed Book 5002, page 782; all records in the office of the Jefferson County Clerk.

2. That the Clerk of this Court shall immediately certify this Judgment to the City Council of the City of Jeffersontown, Kentucky, who shall immediately enter this Judgment on its records.
