ORDINANCE NO. 1465, SERIES 2024

AN ORDINANCE RELATING TO ANNEXATION TO THE CITY OF JEFFERSONTOWN, KENTUCKY A CERTAIN TRACT OF LAND SITUATED APPROXIMATELY EASTERLY IN THE COUNTY OF JEFFERSON, ADJOINING THE PRESENT CITY OF JEFFERSONTOWN, KENTUCKY AND BEING ADJACENT TO AND CONTIGUOUS WITH THE PRESENT BOUNDARY OF SAID CITY AT ITS BOUNDRY WITH TUCKER STATION ROAD AND MORE PARTICULARLY HEREINAFTER DESCRIBED

**WHEREAS**, the City of Jeffersontown, Kentucky has complied with the mandates set forth in KRS 67C.111(3), 81A.412, and 100.209; and,

**WHEREAS**, the City has received the required approval from the Louisville Metro Council to proceed with annexation; and,

WHEREAS, the Louisville Metro Planning Commission has recommended an area wide rezoning from R-4 to PEC – Planned Employment Center in accordance with the City's application pursuant to KRS 100.209; and,

WHEREAS, the City has adopted and enacted said recommendation for area wide rezoning from R-4 to PEC – Planned Employment Center, with other Land Use Regulations, with the adoption of Ordinance No. 1464, Series 2024; and,

WHEREAS, the annexation area is adjacent to and contiguous to the existing boundary of the City of Jeffersontown; and,

WHEREAS, because the boundaries of the proposed annexation area are proximate and contiguous to the largest planned employment center in the region, which is situated within the City of Jeffersontown, Kentucky, the land is urban is character and suitable for development for urban purposes and the City can provide services without any delay; and,

WHEREAS, no part of the annexation area is included within the boundary of another incorporated city; and,

WHEREAS, the number of registered and qualified voters required by KRS 67C.111(3), and one hundred percent (100%) of the real property owners required by KRS 81A.412, have requested this annexation; and,

WHREAS, the City Council desires to go forward with the annexation of the subject property,

### NOW THEREFORE, BE IT ORDAINED BY THE CITY OF JEFFERSONTOWN, KENTUCKY, AS FOLLOWS:

Section1. It is deemed desirable to annex to the City of Jeffersontown, Kentucky, and extend the boundaries of the City of Jeffersontown easterly to include same, that certain tract of land which is now embraced within the County of Jefferson and which is adjacent to and contiguous with the present city boundary at Tucker Station Road and which, by reason of population density and land hold improvements is urban in character and suitable for immediate development, which territory is accurately described and defined as follows on the attached Exhibits A and depicted on the mapping as Exhibit B; said exhibits being incorporated and adopted herein as if completely written within this document.

<u>Section 2</u>. That said territory herein described is annexed into the City of Jeffersontown, Kentucky effective with the publication hereof.

Section 3. The zoning on the subject property shall remain as currently zoned by the City of Jeffersontown, Kentucky in Ordinance No. 1464, Series 2024 pursuant to KRS 100.209, to wit: PEC Planned Employment Center with other Land Use Regulations.


