IN RE: CITY OF JEFFERSONTOWN, KENTUCKY, EX PARTE

JUDGMENT

This cause coming on to be heard on Petition of the City of Jeffersontown, Kentucky, a city of the Fourth Class, and the exhibits thereto, and consent of the owner of the land sought to be annexed and no remonstrance having been filed herein, and no order for granting future time for making defense having been entered herein; and this Court finding that all requirements of K.R.S. 81.210 applicable to said annexation have been complied with,

IT IS HEREBY ORDERED AND ADJUDGED:

1. That a tract of land hereinafter described be, and hereby is, annexed to the corporate limits of the City of Jeffersontown, Kentucky, and that the city boundary of the City of Jeffersontown, Kentucky, is extended to include therein the following tract of land, to-wit:

BEGINNING at a point in the Southerly line of I-64 at its intersection with the Westerly line of Blankenbaker Road as now constructed; thence Eastwardly with the meanderings of the Southerly line of I-64, 369 feet, more or less to a point at its intersection with the Westerly

line of a tract conveyed to A. and A. M. Jones by Deed dated May, 1962, of record in Deed Book 2881, page 103, in the office of the County Court Clerk of Jefferson County, Kentucky; said line also being common with a Westerly line of a tract conveyed to R. F. McMahan, Sr. by Deed dated October 13, 1970 of record in Deed Book 4379, page 335, in the office of the Clerk aforesaid; thence in lines common to McMahan and Jones South 17 degrees 15 minutes East 280 feet; thence North 71 degrees 30 minutes East 200 feet; thence with the Easterly line of the McMahan tract aforesaid, South 17 degrees 15 minutes East 2,015 feet; thence with the Southerly line of the McMahan tract aforesaid, North 88 degrees 45 minutes West 1,333.86 feet to a point in the center line of Blankenbaker Road and continuing thence with the center line of Blankenbaker Road North 88 degrees 45 minutes West 867 feet to the Southwesterly corner of the McMahan tract aforesaid; thence in a line common with the Westerly line of McMahan North 18 degrees West 1,800 feet to the Northwestwardly corner of the McMahan tract aforesaid; said line being common to the Easterly line of a tract conveyed to B. Blankenbaker by Deed dated October, 1956 of record in Deed Book 3415, page 327, in the Clerk's office aforesaid and the Easterly line of a tract conveyed to L. Leroy and Dorothy L. Highbaugh, Jr. by Deed dated May, 1961 of record in Deed Book 3691, page 97 in the Clerk's office aforesaid, and being coincident with the existing boundary line of the City of Jeffersontown, Kentucky, as established by Ordinance No. 381, Series 1964, where said line is common to the Highbaugh tract aforesaid; thence North 72 degrees East 465.2 feet, more or less; thence South 18 degrees East 403.9 feet, more or less; thence North 70 degrees 30 minutes East 624.8 feet, more or less, to the center line of Blankenbaker Road as it existed prior to relocation; thence with the center line of Blankenbaker Road as aforesaid, South 10 degrees 15 minutes East 250 feet, more or less, to the Westerly line of Blankenbaker Road as now constructed; thence Northerly with the Westerly line of Blankenbaker Road to I-64, the point of beginning.

2. That the Clerk of this Court shall immediately certify this Judgment to the City Council of the City of Jeffersontown, Kentucky, who shall immediately enter this Judgment on its records.

3. That the cost of this action shall be paid by the City of Jeffersontown, Kentucky.
