This cause coming on to be heard on Petition of the City of Jeffersontown, Kentucky, a city of the Fourth Class, and the exhibits thereto, and no remonstrance having been filed herein, and no order for granting future time for making defense having been entered herein; and this Court finding that all requirements of K.R.S. 81.210 applicable to said annexation have been complied with,

IT IS HEREBY ORDERED AND ADJUDGED:

1. That a tract of land hereinafter described be, and hereby is, annexed to the corporate limits of the City of Jeffersontown, Kentucky, and that the city boundary of the City of Jeffersontown, Kentucky, is extended to include therein the following tract of land, to-wit:

BEGINNING at a point in the East right of way of Six Mile Lane, said point being South 2 degrees 30 minutes 52 seconds West 60.00 feet from the Southwest corner of the tract conveyed to George Mitchell Montgomery by Deed recorded in Deed Book 2173, page 359, in the office of the County Court Clerk of Jefferson County, Kentucky; thence South 87 degrees 29 minutes 08 seconds East 200.00 feet to a point; thence North 2 degrees 30 minutes 52

seconds East 60.00 feet to a point; thence South 87 degrees 29 minutes 08 seconds East 75.07 feet to a point; thence South 35 degrees 19 minutes 01 seconds East 235.78 feet to a point; thence South 31 degrees 37 minutes 47 seconds West 302.54 feet to a point in the Westerly boundary of the City of Jeffersontown as established by Ordinance No. 382, Series 1964; thence continuing with the call aforesaid and the existing City boundary established as above stated 560.00 feet to a point; thence North 2 degrees 30 minutes 52 seconds East 798.00 feet to a point in the East right of way of Six Mile Lane; thence with the East right of way of Six Mile Lane North 2 degrees 30 minutes 52 seconds East 81.77 feet to the point of beginning, and containing 4.83 acres, more or less.

2. That the Clerk of this Court shall immediately certify this Judgment to the City Council of the City of Jeffersontown, Kentucky, who shall immediately enter this Judgment on its records.

3. That the cost of this action shall be paid by the City of Jeffersontown, Kentucky.
