IT IS ORDERED AND ADJUDGED that the following property  
be and it hereby is annexed to the CITY OF JEFFERSONTOWN, KENTUCKY.  
The property to be annexed is more particularly described as  
follows:

BEGINNING at a point in the Southerly line of I-64, said point being 369 feet East of the Westerly line of Blankenbaker Road as now constructed as measured along the Southerly right-of-way line of I-64, said point also being the point of intersection of the Southerly right-of-way line of Interstate 64 with the Westerly line of the tract conveyed to A. and A. M. Jones by a Deed dated May, 1962, and of record in Deed Book 2881, Page 103, in the Office of the Jefferson County Court Clerk, said line also being common with the Westerly line of the tract conveyed to R. F. McMahan, Sr., by a Deed dated October 13, 1970, and of record in Deed Book 4379, Page 335, in the Office of the Clerk aforesaid, said point also being the Northeast corner of the tract annexed to the City of Jeffersontown by Ordinance No. 538, Series 1971; thence, following the existing Easterly boundary of the City of Jeffersontown in a Southerly direction, said line also being the Easterly line of McMahan aforesaid and the Westerly line of Jones aforesaid South 17 degrees 15 minutes East 280 feet; thence, continuing with the present city boundary of the City of Jeffersontown, North 71 degrees 30 minutes East 200 feet; thence, continuing with the present Easterly boundary of the City of Jeffersontown and the Easterly line of the McMahan tract aforesaid, South 17 degrees 15 minutes East 2015 feet to the Southeast corner of the lands annexed into the City of Jeffersontown by Ordinance No. 538, Series 1971, and the Southeast corner of the McMahan tract aforesaid, said point also being the Northeast corner of the tract annexed into the City of Jeffersontown by Ordinance No. 544, Series 1972, thence, continuing with the Easterly boundary of the City of Jeffersontown as established by the last mentioned Ordinance in a Southerly direction South 17 degrees 30 minutes East 1250 feet to the Southeast corner of the tract conveyed to R. F. McMahan, Sr., by a Deed dated September 20, 1971, and of record in Deed Book 4457, Page 520, in the aforesaid Clerk's Office, said point

also being the Southeast corner of the tract annexed into the City of Jeffersontown by the last mentioned Ordinance; thence, leaving the existing boundary of the City of Jeffersontown in a Southerly direction South 13 degrees 06 minutes 45 seconds East 426.27 feet to the Southwest corner of the lands conveyed to Commonwealth Park Development Company as described in a Deed of record in Deed Book 4721, Page 272, in the Office of the Clerk aforesaid; thence, following the Southerly line of the Commonwealth Park Development Company tract in an Easterly direction North 48 degrees 44 minutes 30 seconds East 1,012.94 feet to a point; thence, continuing with the Southerly line of the Commonwealth Park Development Company tract in an Easterly direction North 51 degrees 54 minutes 00 seconds East 531.37 feet to a point; thence, continuing with said Southerly line in an Easterly direction North 76 degrees 39 minutes 30 seconds East 323.20 feet to a point in Tucker Station Road as now existing; thence, North 15 degrees 36 minutes 38 seconds West 150.58 feet to a point; thence, continuing with the Southerly line of the Commonwealth Park Development Company tract aforesaid in an Easterly direction North 76 degrees 13 minutes 30 seconds East 332.92 feet to the Southeast corner of the Commonwealth Park Development Company tract in a Northerly direction North 16 degrees 16 minutes 10 seconds West 2,435.23 feet to a point of intersection with the South line of I-64 aforesaid; thence, following the South line of I-64 in a Westerly direction North 86 degrees 50 minutes 40 seconds West 2,015.07 feet to a point in said Southerly line of I-64; thence, continuing with the Southerly line of I-64 in a Westerly direction North 86 degrees 55 minutes 00 seconds West 409.73 feet, more or less, to the point of beginning and the Easterly boundary of the City of Jeffersontown as first herein described and the Westerly line of Jones aforesaid.
