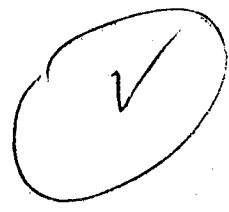

This cause coming on to be heard on Petition of the City of Jeffersontown, Kentucky, a city of the Fourth Class, and the exhibits thereto, including consent of the sole owners of the land sought to be annexed, and no remonstrance having been filed herein, and no order for granting future time for making defense having been entered herein; and this Court finding that all requirements of K.R.S. 81.210 applicable to said annexation have been complied with,

IT IS HEREBY ORDERED AND ADJUDGED:

1. That a tract of land hereinafter described be, and hereby is, annexed to the corporate limits of the City of Jeffersontown, Kentucky, and that the city boundary of the City of Jeffersontown, Kentucky, is extended to include therein the following tract of land, to-wit:

BEGINNING at a point in the easterly boundary line of Locust Lane at its intersection with the Northerly right of way line of Watterson Trail, said point being in the boundary line of the City of Jeffersontown as established by Ordinance No. 193, Series 1956; thence with the Northerly line of Watterson Trail South 66 degrees West 333.00 feet, more or less; North 1 degree 45 minutes East 237.18 feet, more or less; South 88 degrees 30 minutes East 300.00 feet, more or less; South 1 degree 45 minutes West 83.35 feet, more or less, to the point of beginning.



2. That the Clerk of this Court shall immediately certify this Judgment to the City Council of the City of Jeffersontown, Kentucky, who shall immediately enter this Judgment on its records.

3. That the cost of this action shall be paid by the City of Jeffersontown, Kentucky.

This is a Final Judgment.
