AN ORDINANCE RELATING TO:

ANNEXATION TO THE CITY OF JEFFERSONTOWN, KENTUCKY  
OF A TRACT OF LAND LYING WEST OF THE EXISTING  
CITY BOUNDARY FRONTING ON HURSTBOURNE LANE

WHEREAS, Ordinance No. 790, Series 1982, has been enacted by the City Council of Jeffersontown, Kentucky, pursuant to KRS 81A 420; and,

WHEREAS, more than 60 days next following the enactment of said Ordinance have passed; and,

WHEREAS, no petition has been received by the Mayor as set out in KRS 81A 420; and

WHEREAS, KRS 81A 420 (3) provides for an annexing ordinance;

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF JEFFERSONTOWN, KENTUCKY:

SECTION I. The City of Jeffersontown, Kentucky, having enacted Ordinance No. 790, Series 1982, proposing to annex to the City of Jeffersontown, Kentucky, and to extend the boundaries thereof to include a certain tract of land, and whereas more than 60 days next following said enactment have elapsed, and whereas the Mayor of said Jeffersontown, Kentucky has received no petition from the property owners of qualified voters residing therein, the boundaries of the City of Jeffersontown, Kentucky, are extended to include a certain tract of land described as hereinafter set forth, said tract of land all lying within the County of Jefferson, and adjacent to the City of Jeffersontown, Kentucky, and bounded and described as follows, to-wit:

Beginning at the point of intersection of the West line of Hurstbourne Lane and the North right-of-way line of Ramp 9 of the Hurstbourne Lane Interchange with Interstate 64 as shown on the drawings on file at the Office of the Kentucky Department of Transportation; thence with the North right-of-way line of said Ramp North  $31^{\circ} 53' 41''$  West 446.20 feet; thence leaving said right-of-way line of said Ramp and with the East line of Hurstbourne Park Boulevard North  $56^{\circ} 15'$  East 117.45 feet; thence continuing with said line of said Hurstbourne Park Boulevard and with a curve to the right said curve having a radius of 30 feet, a chord of which is South  $78^{\circ} 41'$  East 42.55 feet; thence with the South line of said road South  $33^{\circ} 41'$  East to the point of intersection of said line with the extension of the West line of the Hurstbourne Park Boulevard Connector as shown on the drawings for the improvement of the Hurstbourne Lane Interchange with Interstate 64, on file in the Office of the Kentucky Department of Transportation; thence crossing Hurstbourne Park Boulevard along said extension of the West line of said Hurstbourne Park Boulevard Connector North  $58^{\circ} 06' 19''$  East 60.00 feet, more or less, to the point of intersection of the North line of said Hurstbourne Park Boulevard with the West line of the aforesaid Hurstbourne Park Boulevard Connector; thence with the West line of said connector North  $58^{\circ} 06' 19''$  East 232.60 feet; thence leaving said line of said Connector and with the South line of the tract conveyed to Budget Inns Investment Co. by Deed Book 4810, Page 464 of record in the Office of the Clerk of Jefferson County, Kentucky, North  $33^{\circ} 41'$  West 1026 feet, more or less, to the point of intersection of said line with the South line of Interstate 64; thence with the South line of Interstate 64 South  $62^{\circ} 03' 33''$  East 310.92 feet; thence South  $52^{\circ} 42' 08''$  East 412.80 feet; thence South  $45^{\circ} 03' 49''$  East 367.97 feet to the point of intersection of the South line of Interstate 64 with the West line of Hurstbourne Lane, said point also being in the East boundary of the City of Jeffersontown as established by Ordinance 672, Series 1976; thence in a Southerly direction with the West line of Hurstbourne Lane and the existing City of Jeffersontown boundary to the point of beginning.

SECTION II. That all ordinances or parts of ordinances conflicting with the provisions of this ordinance are hereby repealed, insofar as they affect this ordinance.

SECTION III. The Clerk of the Council is hereby directed to publish a copy of this ordinance immediately in a newspaper having the largest daily circulation in the City of Jeffersontown, Kentucky.

SECTION IV. This ordinance shall take effect and be in force immediately upon its passage and publication.

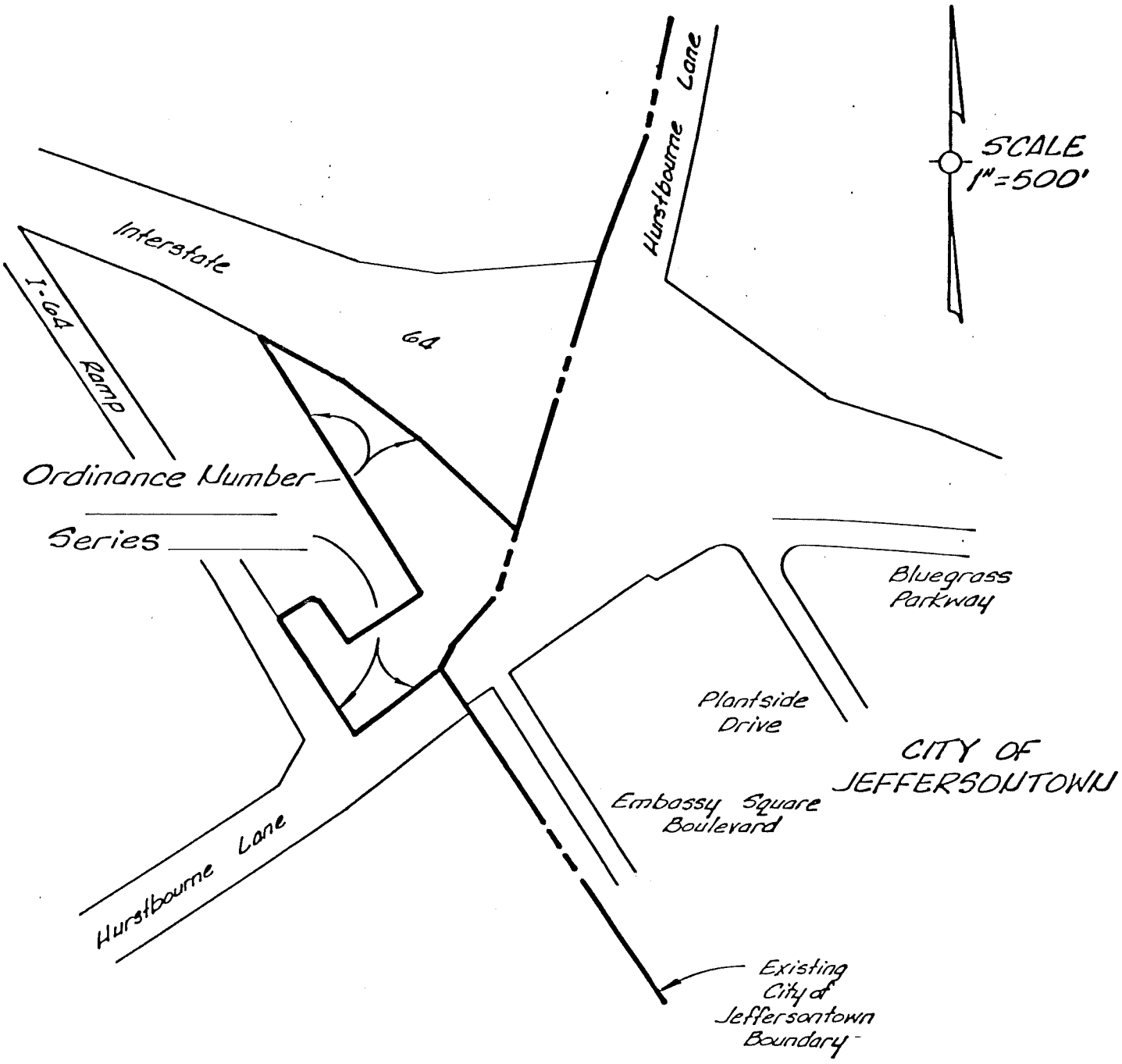
