

ORDINANCE NO. 811, SERIES 1982

AN ORDINANCE RELATING TO:

ANNEXATION TO THE CITY OF JEFFERSONTOWN, KENTUCKY OF A TRACT OF LAND LYING EAST OF THE EXISTING CITY BOUNDARY FRONTING ON WATTERSON TRIAL.

WHEREAS, Ordinance No. 805, Series 1982, has been enacted by the City of Jeffersontown, Kentucky, pursuant to KRS 81A420; and,

WHEREAS, more than sixty (60) days next following the enactment of said Ordinance have passed; and,

WHEREAS, no petition has been received by the Mayor as set out in KRS 81A420; and,

WHEREAS, KRS 81A420(3) provides for an annexation Ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF JEFFERSONTOWN, KENTUCKY:

SECTION I. The City of Jeffersontown, Kentucky having enacted Ordinance No. 805, Series 1982, proposing to annex to the City of Jeffersontown, Kentucky, and to extend the boundaries hereof to include a certain tract of land, and,

WHEREAS, more than sixty (60) days next following said enactment have elapsed, and,

WHEREAS, the Mayor of said Jeffersontown, Kentucky has received no petition from the property owners of qualified voters residing therein, the boundaries of the City of Jeffersontown, Kentucky are extended to include a certain tract of land designated as hereinafter set forth, said tract of land all lying within the County of Jefferson and adjacent to the City of Jeffersontown, Kentucky, and bounded and described as follows, to-wit:

Beginning at a point in the East right-of-way line of Watterson Trail, said point being the Northwest corner of the tract conveyed to Henry Bancroft by Deed Book 3434, Page 116 of record in the Office of the Clerk of Jefferson County, said point being in the existing boundary of the City of Jefferson-town as established by Codified Ordinance No. 110.39, thence leaving the East line of Watterson Trail and following the aforesaid city boundary South 21 degrees East 1584 feet more or less to a point in the North line of the tract conveyed to L. Leroy Highbaugh, Jr. by Deed Book 4654, Page 289 of record in the aforesaid clerk's office, said point also being in the existing boundary of the City of Jeffersontown as established by Ordinance 717 Series 1979; thence with said existing City boundary and the lines of the aforesaid Highbaugh tract South 77 degrees 25' 19" West 584.77 feet; thence South 15 degrees 04' 19" East 1073.96 feet; thence South 74 degrees 55' 41" West 401.41 feet; thence with a curve to the right, said curve having a radius of 1072.84 feet a chord of which is South 87 degrees 19' 37" West 460.72'; thence North 80 degrees 16' 26" West 101.32 feet; thence with a curve to the right, said curve having a radius of 50 feet a chord of which is North 34 degrees 02' 36" West 72.21 feet; thence North 77 degrees 48' 46" West 35 feet to a point in the East right-of-way line of Watterson Trail; thence in a northerly direction with the easterly line of Watterson Trail and the existing City of Jeffersontown boundary 3,000 feet more or less to the point of beginning.

SECTION II.

That all ordinances or parts of ordinances conflicting with the provisions of this ordinance are hereby repealed, insofar as they affect this ordinance.

SECTION III. The clerk of the Council is hereby directed to publish a copy of this Ordinance immediately in a newspaper having the largest daily circulation in the City of Jeffersontown, Kentucky.

SECTION IV. This Ordinance shall take effect and be in force immediately upon its passage and publication.

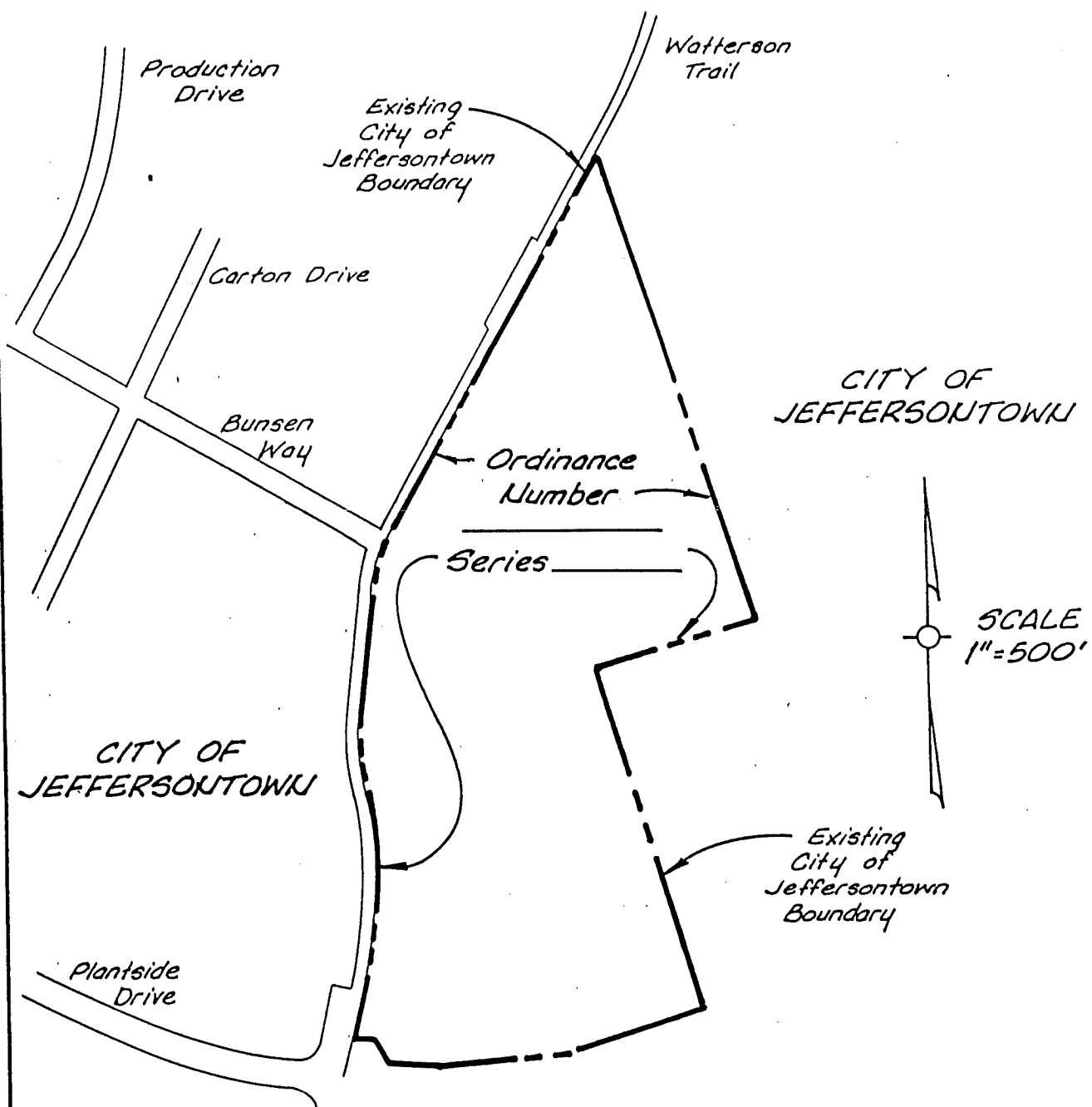
