

ORDINANCE NO. 815, SERIES 1982

AN ORDINANCE RELATING TO:

ANNEXATION TO THE CITY OF JEFFERSONTOWN, KENTUCKY OF A
TRACT OF LAND LYING NORTH AND WEST OF THE EXISTING CITY
BOUNDRY FRONTING ON HURSTBOURNE LANE AT SHELBYVILLE ROAD

WHEREAS, Ordinance No. 807, Series 1982, has been enacted
by the City of Jeffersontown, Kentucky, pursuant to KRS 81A420; and,

WHEREAS, more than sixty (60) days next following the
enactment of said Ordinance have passed; and,

WHEREAS, no valid petition has been received by the Mayor as
set out in KRS 81A420; and,

WHEREAS, KRS 81A420(3) provides for an annexation Ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF JEFFERSONTOWN,
KENTUCKY:

SECTION I. The City of Jeffersontown, Kentucky have enacted
Ordinance No. 807, Series 1982, proposing to annex to the City of
Jeffersontown, Kentucky, and to extend the boundaries hereof to include
a certain tract of land, and,

WHEREAS, more than sixty (60) days next following said enact-
ment have elapsed, and,

WHEREAS, the Mayor of said Jeffersontown, Kentucky has received
no valid petition from the property owners of qualified voters residing
therein, the boundaries of the City of Jeffersontown, Kentucky are
extended to include a certain tract of land designated as hereinafter
set forth, said tract of land all lying within the County of Jefferson
and adjacent to the City of Jeffersontown, Kentucky, and bounded and
described as follows, to-wit:

BEGINNING at a point in the south right-of-way line of Shelbyville Road (U.S. Highway 60) said point also being the northeast corner of Plainview Subdivision as recorded in Plat and Subdivision Book 30, Pages 21 and 22, in the Office of the Clerk of Jefferson County, Kentucky, said point also being in the existing boundary line of the City of Jeffersontown as established by Ordinance Number 575, Series 1973; thence in a southerly direction with said existing City boundary line and the West line of said subdivision the following calls; South 11 degrees 9 minutes 49 seconds East 980.71 feet; thence South 17 degrees 50 minutes 11 seconds West 38.94 feet; thence South 11 degrees 29 minutes 49 seconds East 184.15 feet; thence North 88 degrees 28 minutes 49 seconds West 479.90 feet; thence South 01 degree 31 minutes 11 seconds West 335.92 feet to a stone corner common to the aforesaid subdivision and in the South line of Ansonia Subdivision as recorded in Plat and Subdivision Book 1, Page 209 in the aforesaid Clerk's office, thence leaving the existing City boundary as created by Ordinance 575, Series 1973 and following the existing boundary of the City of Jeffersontown as established by Ordinance 672, Series 1976 and the South line of Ansonia Subdivision in an easterly direction 1185 feet, more or less, continuing with said line as extended and projected to the westerly right-of-way line of Hurstbourne Lane; thence in a northerly direction with the West right-of-way line of Hurstbourne Lane and the East line of Hurstbourne Subdivision Section 5 as recorded in Plat and Subdivision Book 27, Page 31, in the aforesaid Clerk's office, 1878 feet, more or less, to the intersection of the West right-of-way line of Hurstbourne Lane with the South right-of-way line of Shelbyville Road; thence in an easterly direction crossing Hurstbourne Lane to the point of intersection of the East right-of-way line of Hurstbourne Lane and the South right-of-way line of Shelbyville Road; thence in an easterly direction with the South right-of-way line of Shelbyville Road 1366 feet, more or less, to the point of beginning.

SECTION II. That all ordinances or parts of ordinances conflicting with the provisions of this ordinance are hereby repealed, insofar as they affect this ordinance.

SECTION III. The clerk of the Council is hereby directed to publish a copy of this Ordinance immediately in a newspaper having the largest daily circulation in the City of Jeffersontown, Kentucky.

SECTION IV. This Ordinance shall take effect and be in force immediately upon its passage and publication.

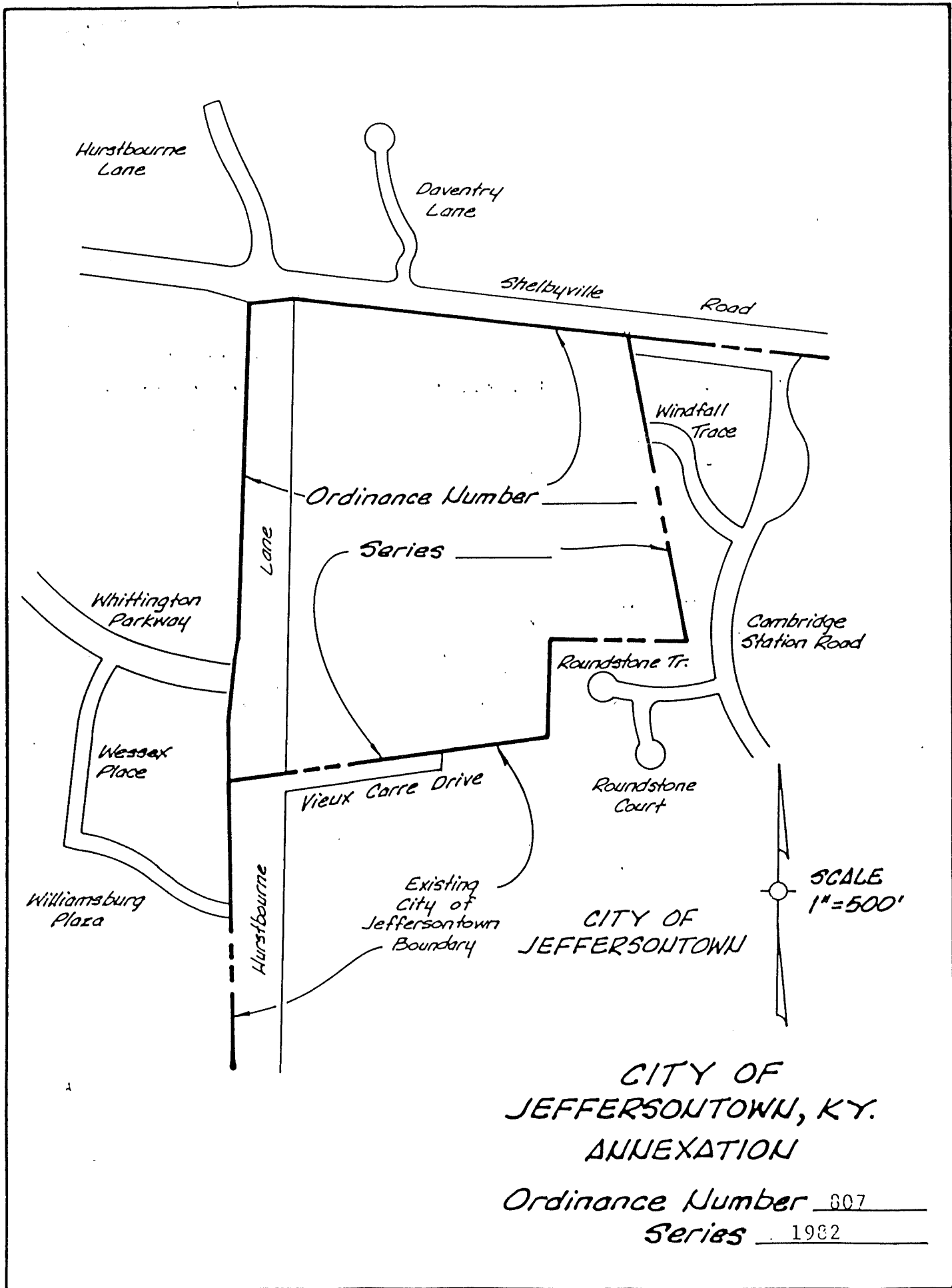
