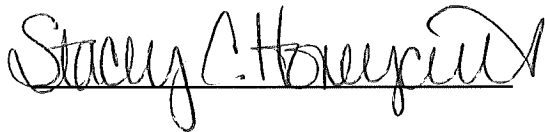

ORDINANCE 2010-6 (2006-4)

WHEREAS, Ordinance Number 2006-4 was enacted on May 22, 2006 by the City of Jeffersonville Commission; and,

WHEREAS, said ordinance was "an ordinance stating an intention to annex certain unincorporated territory contiguous to the City of Jeffersonville"; and,

WHEREAS, in order to prepare an accurate and complete map of the boundaries of the City of Jeffersonville it has become necessary to now adopt an ordinance carrying out the stated intention in the said Ordinance Number 2006-4 to complete the annexation of the territory as described in the aforesaid ordinance; and,

WHEREAS, more than sixty days have elapsed since Ordinance Number 2006-4 went into effect, and no petition containing signatures of property owners in the area to be annexed has been received by the Mayor pursuant to KRS 81A.420.

NOW THEREFORE, be it and it is hereby ordained, by the City Commission of the City of Jeffersonville that the territory described in Ordinance Number 2006-4 be, and it is hereby annexed to, and incorporated in, the territorial boundaries of the City of Jeffersonville.

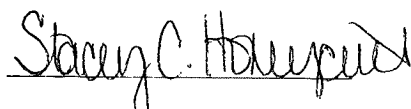
FUTHER, the description of the annexed territory is incorporated herein by reference to the said Ordinance Number 2006 4 as if fully copied at length.

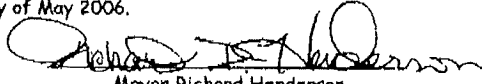

- 3) The tract of land which the City intends to annex is more particularly described as follows:

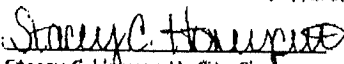

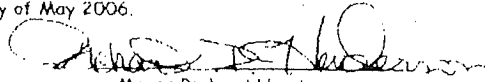

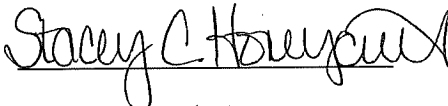

RESOLUTION 2010-06

A RESOLUTION ADOPTING A MODERN AND ACCURATE LEGAL DESCRIPTION OF TERRITORY PREVIOUSLY ANNEXED BY ORDINANCE.

WHEREAS, the City of Jeffersonville has enacted numerous ordinances annexing property into the corporate limits of the City of Jeffersonville; and

WHEREAS, each individual annexation contains a prior survey oft prepared by now unknown individual, and further references documentation that is no longer in existence, and

WHEREAS, the City wishes to provide a modern, accurate, easily identifiable legal description reflecting bearings and coordinates based upon the state plane coordinate system, including relevant GPS and GIS data, same having been certified by a professional land surveyor for each prior annexation; and

WHEREAS, the city wishes to comply with the requirements of Amended KRS 81A.4 70 effective July 13, 2004, and

WHEREAS, the City does not intend to amend or replace its prior ordinance annexing, but rather to interpret the defined boundaries of the territory previously annexed and adopt a modern and accurate legal description of territory previously annexed.

NOW THEREFORE, BE IT RESOVED BY THE BOARD OF COMMISSIONER'S OF THE CITY OF JEFFERSONVILLE, KENTUCKY:

SECTION 1. That the Board of Commissioner's of the City of Jeffersonville hereby adopts the following legal description, and a plat attached hereto as prepared by Alan Justice, Licensed Professional Land Surveyor No. 2360 by new survey as an accurate depiction of the property previously annexed into the corporate city limits of the City of Jeffersonville by Ordinance 2006-4 dated May 25, 2006, a copy of which is attached hereto as Exhibit "2", and hereby adopts said new legal description and plat as the official legal description and plat to be adopted by the City for all purposes when referencing this prior annexation.

Beginning at a point located S 06 deg. 45 min. 42 sec. W, 458.66 feet from the intersection of Silver Ridge Road and Maloney Road; thence S 48 deg. 40 min. 57 sec. W, 526.77 feet to a point; thence S 51 deg. 02 min. 00 sec. W, 145.49 feet to a point; thence S 38 deg. 02 min. 00 sec. W, 251.48 feet to a point; thence N 51 deg. 58 min. 00 sec. W, 600.00 feet to a point; thence N 38 deg. 02 min. 00 sec. E, 319.84 feet to a point; thence N 51 deg. 02 min. 00 sec. E, 201.54 feet to a point; thence N 48 deg. 40 min. 57 sec. E, 514.46 feet to a point; thence S 41 deg. 19 min. 03 sec. E. 600.00 feet to the point of beginning.

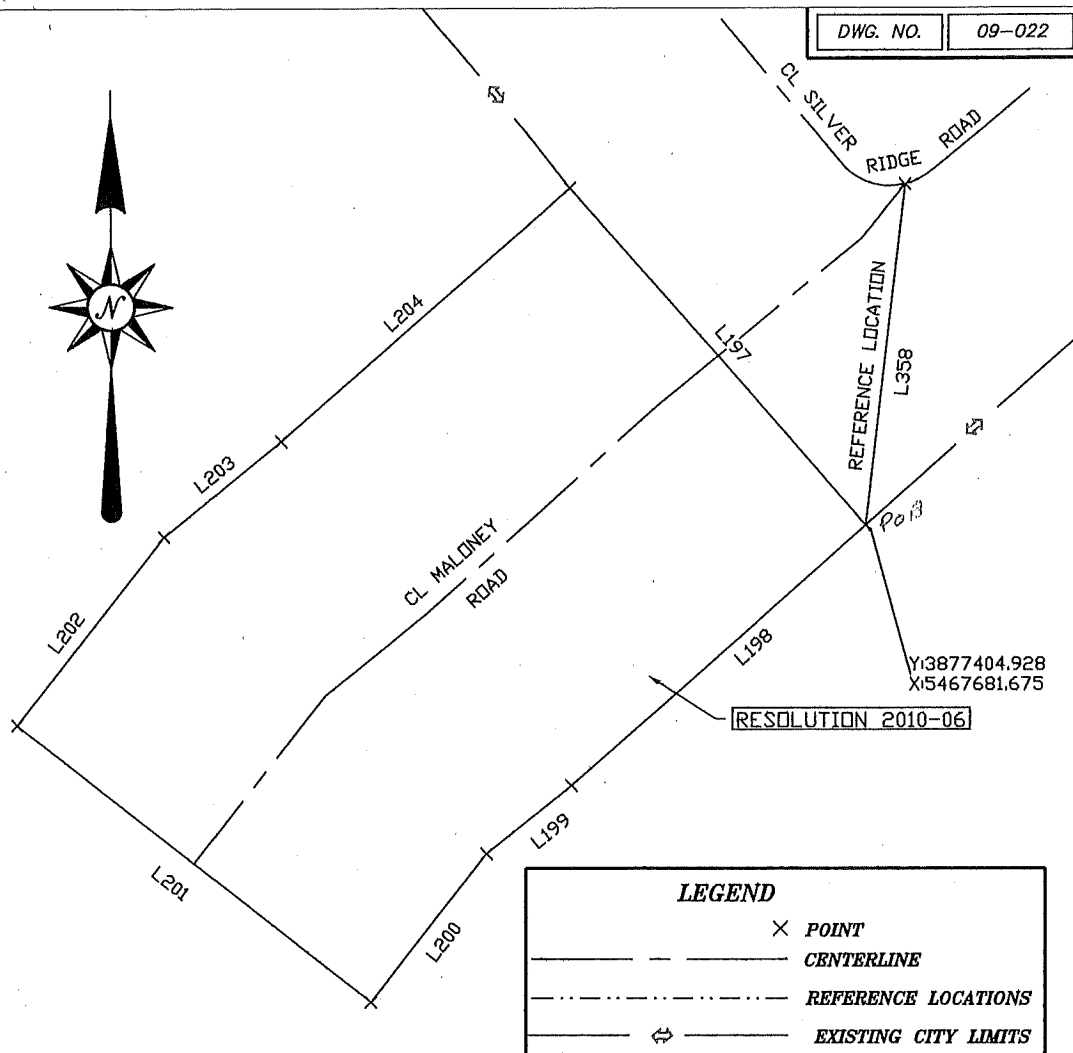
