ORDINANCE NO. 1992-25

ORDINANCE ANNEXING UNINCORPORATED TERRITORY INTO THE CITY
OF KEVIL, KENTUCKY

BE IT ORDAINED BY THE CITY OF KEVIL, KENTUCKY:

SECTION 1: The hereinafter described property being served by city water and the city sewer system and therefore it is desirable that said property be annexed into the city limits of the City of Kevil.

SECTION 2: It is the intent of the City of Kevil to annex the following described property and it is hereby annexed into the corporate limits of the City of Kevil, Kentucky, to-wit:

Beginning at a point in the West line of the Maude Hook property, said point being South 04 degrees 57 minutes 26 seconds East 236.92 feet from centerline of U.S. Highway No. 60; thence South 73 degrees 14 minutes 45 seconds East 401.00 feet; thence South 13 degrees, 56 minutes 34 seconds West 1.00 feet; thence South 75 degrees 00 minutes 00 seconds East 95.00 feet; thence North 13 degrees 56 minutes 34 seconds East 206.00 feet; thence South 75 degrees 00 minutes 00 seconds East 655.62 feet; thence South 02 degrees 42 minutes 23 seconds East 220.00 feet; thence South 75 degrees 00 minutes 00 seconds East 429.57 feet; thence South 04 degrees 19 minutes 15 seconds East 780.31 feet; thence South 85 degrees 25 minutes 32 seconds West 1531.00 feet; thence North 04 degrees 57 minutes 26 seconds West 13.47.08 feet, to the point of beginning, containing 40.613 acres, all as shown by Plat of Survey prepared in February 1988 by Donald D. Simmons, Registered Land Surveyor.

Being in all respects the same property to which Ballard County Economic and Industrial Development Board, Inc., a Kentucky corporation, derived title by Deed dated March 4, 1988, from Clyde M. Elrod, Executor of the Maude Elrod Hook Estate, and appears of record in Microfilm Cabinet 1, Drawer 11, Card No. 20,957, Ballard County Court Clerk's Office.

SECTION 3. Enacted at it's first reading on December 1, 1992, and at it's second reading on December 29, 1992.
