ORDINANCE NO. 1994-15

An Ordinance Annexing Certain
Unincorporated Territory Into
The City Limits Of The City
Of Kevil, Kentucky

BE IT ORDAINED BY THE CITY OF KEVIL, KENTUCKY:

Section 1

Pursuant to the consent of and request of the owner thereof
there is hereby annexed into the city of Kevil, Kentucky the
following described tract or parcel of land:

Being at an iron rod in the east right away line of Kentucky Highway 473 and the Northwest corner of property owned by Ballard County Senior Citizen's Organization and described in Cabinet 1, Drawar 8, Card No. 12, 806; thence, South 70 Degrees 50 minutes East 178.25 feet to an iron rod at a fence corner; thence continuing South 71 Degrees 8 minutes East 350.40 feet to an iron rod at the ruins of an old fence corner that is North 17 Degrees 15 minutes East 184.38 feet to an iron rod set at fence corner; thence North 19 Degrees 31 minutes East 415.73 feet to an iron rod set in a fence line, the Northeast corner of this property; thence North 77 Degrees 00 minutes West 302.03 feet to a point in the center of the creek; thence South 26 Degrees 39 minutes West 175.10 feet with said creek; thence South 77 Degrees 00 minutes East 216.80 feet to a stack in the East right of way line of Kentucky Highway 473; thence South 19 Degrees. 22 minutes West 42.5 feet to a stake; thence South 70 Degrees 38 minutes East 20 feet to a stake; thence South 19 Degrees 22 minutes West 230 feet to a stake, the point of beginning.
