THE KEVIL CITY COUNCIL MET IN REGULAR SESSION SEPTEMBER 12, 1994 AT 7.00 PM. PRESENT WERE: MARY FRANCES WHITE, PHILIP BABB, JOHN SUMMERS, CHARLES BURNLEY, BOBBY HOOK, HAROLD STONE, CHARLIE TRICE AND JIMMY YOUNGBLOOD.

MARY FRANCES WHITE ASKED HOW THE NEW RESIDENTS OF THE CITY COULD BE NOTIFIED ABOUT THE DOG LAW. AFTER SOME DISCUSSION IT WAS AGREED THAT MRS. WHITE GET NAMES OF PEOPLE THAT HAVE DOGS RUNNING LOOSE AND REPORT TO LOUISE, LOUISE WILL THEN SEND A LETTER TO THEM TELLING THEM ABOUT THE ORDINANCE.

PHILIP BABB ASKED THE NAME OF HIS STREET BE CHANGED FROM ELVIRA LANE TO BABB LANE. MOTION BY HAROLD TO CHANGE THE NAME OF THE STREET. SECOND BY BOBBY MOTION CARRIED. PHILIP ALSO HAS SOME LOTS THAT ARE TOO LOW TO BE DRAINED OF WASTE WATER WITH OUT A LIFT STATION. IT WAS SUGGESTED, HE PUT IN A LIFT STATION AT HIS EXPENSE OR USE SEPTIC TANKS. IF THE SEPTIC TANKS ARE USED HE MAY NEED TO CALL THE HEALTH DEPT, STATING THE CITY HAS GIVEN PERMISSION FOR THE SEPTIC TANKS TO BE USED. MAYOR SUGGESTED IF THIS WAS NOT SATISFACTORY MR BABB COULD BRING SUIT ASKING THE LOTS BE REMOVED FROM THE CITY.

JOHN SUMMERS HAD ASKED IF LOTS 45 AND 46 IN PHASE II OF WHISPERING OAKS COULD BE ANNEXED INTO THE CITY. COUNCIL SUGGESTED THAT PHASE III IN BALLARD COUNTY AS WELL AS LOTS 45 AND 46 IN PHASE II BE ANNEXED.

(LOTS IN PHASE III ARE 75 76 77 94 95 96 AND 99 AND 99 TO 122) THE FIRST READING OF THE ORDINANCE # 1994-20 WAS HELD SEPTEMBER 12, 1994. LOT # 46 HAS BEEN BOUGHT BY MR JAMES SKILES. HE IS TO PAY \$150.00 FOR SEWER TAP ON AND D & N CONST IS TO LAY THE LINES. IN THE AGREEMENT WITH MR SUMMERS ON WHISPERING OAKS, MR SUMMERS IS TO PAY THE FULL TAP ON FEE OF \$400.00. CLERK IS TO COMPUTE ACTUAL COST AND REFUND BALANCE TO MR SUMMERS.

MAYOR READ AN ORDINANCE FROM BALLARD RURAL TELEPHONE STATING THE TELEPHONE LINES, POLES AND OTHER EQUIPMENT IN THE CITY BELONG TO BALLARD RURAL COOP CORP AND THEY HAVE A FRANCHISE WITHIN THE CITY LIMITS. CHARLIE TRICE BOBBY HOOK MADE MOTION TO PASS THE ORDINANCE SECOND BY HAROLD. THE FIRST READING OF ORDINANCE 1994-16 WAS HELD SEPTEMBER 12 1994. SECOND READING WILL BE SEPTEMBER 13, 1994 AT 8:00 A.M.
