CONSENT

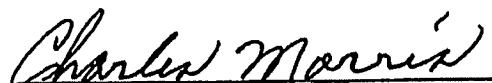
Comes now the undersign owners of the hereinafter described properties and consent to and request the City of Kevil, Kentucky, to the annex into the city limits the following described tract or parcel of land:

Lying on the Southerly side of U.S. Highway 60 and being part of the Charles and Edith Morris property recorded in Cabinet 1, Drawer 17, Card No. 34939 and part of the George ad Kathryn Anderson property recorded in Cabinet 1, Drawer 2, Card No. 384, Ballard County Court Clerk's Office, Ballard County, Kentucky, and more particularly bounded and described as follows to wit:

Beginning at a point in the Southerly right-of-way line of U.S. Highway 60 (30 feet from the centerline thereof) at the Northwesterly corner of the Charles and Edith Morris property recorded in Cabinet 1, Drawer 17, Card No. 34939, said point being square to a point in the centerline of said U.S. Highway 60 that is 234.6 feet as measured Northwestwardly along said centerline from its intersection with the centerline of South Nuckolls Avenue; THENCE FROM SAID POINT OF BEGINNING Southeastwardly with the Southerly right-of-way line of said U.S. Highway 60, 438.43 feet to a point in the centerline of a ditch; thence interior angle 89 deg. 32' 09" and Southwardly with the centerline of said ditch 200.01 feet to a point; thence interior angle 90 deg. 27' 51" and Northwestwardly parallel and 200 feet Southwardly therefrom the Southerly right-of-way line of aforesaid U.S. Highway 60, 364.78 feet to a point in the Westerly line of aforesaid Charles and Edith Morris property; thence interior angle 109 deg. 48' 25" and Northwardly with said Westerly line 212.58 feet to a ½ inch rebar, the point of beginning, making a closing interior angle of 70 deg. 11' 35" and containing 1.844 acres as shown on "Plat of Proposed Annexation for City of Kevil" prepared by Hunter Martin & Associates, Inc., dated November 11, 1997.
