CONTARY OF STATE

ORDINANCE ANNEXING JAMES STEPHENSON & BEVERLY STEPHENSON PROPERTY & Quil

WHEREAS, a certain area lies outside the City of Kuttawa, Kentucky, contiguous with the City limits of said City of Kuttawa;

WHEREAS, said hereinafter described property is suitable for development by its owners, without unreasonable delay;

WHEREAS, it is desirable and necessary for the consistent well ordered growth of the City of Kuttawa, Kentucky, that the hereinafter described property be annexed and brought into the City of Kuttawa, Kentucky; and

WHEREAS, the property to be annexed is zoned residential which zoning shall remain in full force and effect;

WHEREAS, all owners of record as to the herein described property have given their prior written consent to for annexation of the hereinafter described property;

NOW, THEREFORE, BE IT ORDAINED AND ESTABLISHED in accordance to KRS 81A.412 that the hereinafter described property is hereby annexed by the City of Kuttawa, Kentucky,

TRACT II: A tract of land in Lyon County, Kentucky, lying in the City of Kuttawa, Kentucky - near Lake Clough - on the West side of West Clough Drive, (shown as East Clough Drive by Plat of Record), at its intersection with Magnolia Drive and East Clough Drive - and better described as follows:

Beginning at the Northeast corner, a 1/2 inch rebar marked Randy Gray 2932, found at a fence corner 38.19 feet West of center of West Clough Drive, and being a corner with the City of Kuttawa - Block G - its State Plane Coordinates being, -N- 1913183.22512 -E-946121.87318; thence; from said point of beginning, and with the Kuttawa Relocation Foundation Green Strip as shown by Plat, as recorded in Plat Cabinet 1, Slide 17,

-S-14-51-09-E- 150.00 feet to a 5/8 inch iron pin, set, 48.38 feet West of center said West Clough Drive; thence; a new division line, -S-63-57-22-W-150.00 feet to a 5/8 inch iron pin, set; thence -N-14-51-09-W-150.00 feet to a 5/8 inch iron pin, set, in the City of Kuttawa Block G line; thence; with their line, -N-63-57-22-E-150.00 feet to the point of beginning containing 0.5067 acres.
