ORDINANCE OF ANNEXATION

(a portion of The Springs Subdivision)

WHEREAS, there has been a continual development of property in Kuttawa, Lyon County, Kentucky; and

WHEREAS, it is desirable and necessary for the consistent well-ordered growth of the City of Kuttawa, Kentucky, that the following described property be annexed and brought into the City of Kuttawa, to-wit:

A TRACT OF LAND IN LYON COUNTY, KENTUCKY, LYING ON THE WESTERLY SIDE OF HIGHWAY 295, AND ON THE NORTHERLY SIDE OF INTERSTATE 24 AND BARKLEY LAKE, AND GENERALLY BOUNDED ON THE SOUTH BY LANDS OF THE UNITED STATES OF AMERICA TRACT 1124, THE WEST BY LANDS OF ROBERT D. YATES, ON THE NORTH BY LANDS OF CHARLES AND DELLA OLIVER AND BACCUS OLIVER, AND ON THE EAST BY PORTIONS OF THE SPRINGS SUBDIVISION, AND BEING THAT PORTION OF THE SPRINGS SUBDIVISION THAT WAS NOT PREVIOUSLY INCLUDED IN THE CITY LIMITS OF KUTTAWA, KENTUCKY:
