AN ORDINANCE PURSUANT TO THE PROVISIONS OF KRS 81A.410, KRS 81A.412 AND 81A.420 AND ALL OTHER APPLICABLE LAW ANNEXING THE PROPERTY PRESENTLY CONTIGUOUS TO THE EXISTING LAGRANGE CORPORATE LIMITS

The land which is the subject of this annexation is more fully and particularly described in the attached Exhibit "A" and the attached survey.

Henceforth from the date of passage and publication of this Ordinance, according to law, the property described in the attached exhibit is hereby incorporated into the City of LaGrange and is now part of said City.
