ORDINANCE NO. 7-95

AN ORDINANCE PURSUANT TO THE PROVISIONS OF

KRS 81A.412 AND ALL OTHER

APPLICABLE LAW ANNEXING THE PROPERTY PRESENTLY

CONTIGUOUS TO THE EXISTING LAGRANGE CORPORATE LIMITS

BE IT ORDAINED BY THE CITY OF LAGRANGE, KENTUCKY AS FOLLOWS:

The City of LaGrange, pursuant to the provisions of KRS 81A.412 and all other applicable law does hereby declare that the below described tract of land adjoining and touching the City limits of the City of LaGrange is annexed to the City of LaGrange. All property owners within the land to be annexed have given their written consent to this annexation is more fully and particularly described in the attached exhibit marked Exhibit "A" which includes a legal description and a survey. This legal description and survey is incorporated herein as if fully set out.

WHEREFORE, pursuant to KRS 81A.412 the tract of property attached in Exhibit "A" is hereby annexed to the City of LaGrange. Henceforth, from the date of the passage and publication of this Ordinance, according to law, the one tract of land described in Exhibit "A", is hereby incorporated into the City of LaGrange and is now part of said City.


