AN ORDINANCE PURSUANT TO THE PROVISIONS OF  
KRS 81A.410 AND 81A.420 AND ALL OTHER APPLICABLE  
LAW ANNEXING THE PROPERTY PRESENTLY CONTIGUOUS TO  
THE EXISTING LAGRANGE CORPORATE LIMITS

BE IT ORDAINED BY THE CITY OF LAGRANGE, KENTUCKY AS  
FOLLOWS:

The City of LaGrange, pursuant to the provisions of KRS  
81A.410 and KRS 81A.420 and all other applicable law does hereby  
declare that the below described tract of land adjoining and  
touching the City limits of the City of LaGrange is annexed to  
the City of LaGrange. The land which is the subject of this  
annexation is more fully and particularly described as follows:

Beginning at a point in the southeasterly line of  
Water Works Road at the common corner of Lot 111 and  
Lot 112 as shown on the plat of GREENWOOD COMMON  
SUBDIVISION as recorded in Plat Book 3, Page 106 in  
the Office of the Clerk of the county Court of  
Oldham County, Kentucky; thence from the point of  
beginning and following the said southeasterly line  
of said Water Works Road as established by the said  
Subdivision and a tract of land conveyed to Milburn  
Walker, as recorded in Deed Book 126, page 595 in  
said Office the following: S 33 07 14 W 50.18 feet  
to the beginning point of curve to the right  
having a radius of 1132.66 feet a chord of which  
bears @ 37 23 14 W and a distance of 168.52 feet to  
a point at the end of said curve; S 41 39 13 W 37.25  
feet to a point; S 43 09 15 W 51.84 feet to a point;  
S 55 19 51 W 130.22 feet to a point at the northwest  
corner of the said Milburn Walker tract; thence N 08  
52 34 W 68.68 feet to a point; thence along the east  
line of KY. State Highway 53 with a curve to the  
left having a radius of 2914.90 feet, a chord of  
which bears N 11 58 15 W for a distance of 246.17  
feet to a point in said east line at the southwest  
corner of a tract of land conveyed to Donald Adams  
as recorded in Deed Book 176 Page 564 in said  
Office; thence leaving said east line of Highway 53,  
eastwardly along the south line of said Adams tract,  
N 59 09 35 E 197.52 feet to a point at the southeast  
corner of said Adams tract, thence northwardly, in  
part along the east line of the said Adams tract, N  
15 11 39 W 99.40 feet to a point at the southwest  
corner of a tract of land conveyed to Robert  
McRoberts as recorded in Deed Book 171, Page 632 in  
said Office; thence eastwardly, along a  
southwestwardly line of the said McRoberts tract, S  
41 13 56 E 209.88 feet to a point at McRoberts  
southeast corner in the northwesterly line of the  
said Water Works Road; thence crossing said  
WaterWorks Road, S 24 24 38 E 67.82 feet to the  
point of beginning and containing 2.65 acres as  
shown on the attached survey which is attached  
hereto and made a part hereof as if fully set out.


More than sixty (60) days has elapsed since the passage and
