## **ORDINANCE NO. 2-2010**

AN ORDINANCE PURSUANT TO THE PROVISION OF KRS 81A.410 AND KRS 81A.412 AND 220.530 AND ALL OTHER APPLICABLE LAW ANNEXING THE PROPERTY PRESENTLY CONTIGUOUS TO THE EXISTING LA GRANGE CORPORATE LIMITS LOCATED AT 2100 SOUTH STATE HIGHWAY 53

BE IT ORDAINED BY THE CITY OF LAGRANGE, KENTUCKY, AS FOLLOWS:

The City of LaGrange, pursuant to KRS 81A.410 and 81A.412 and 220.530 and all other applicable law does hereby declare that the tract of land described in the attached plat and description adjoining and touching the city limits of the City of LaGrange is hereby annexed into the City of LaGrange. All property owners within the land to be annexed have given their written consent to this annexation. The land which is the subject of this annexation is more fully and particularly described in the attached exhibits which include a legal description and plat for the 1.50 =/- acres of property located at 2100 South Ky Highway 53. The legal description and plat are incorporated herein as if fully set out. However, any existing roadways whether public or private within the area annexed shall remain the responsibility of the property owner to maintain. The City of LaGrange does not accept the maintenance of any roadway by reason of this annexation without a separate ordinance accepting the roadway for city maintenance.

WHEREFORE, pursuant to KRS 81A.410 and 81A.412 and 220.530, the tract of property described in the attached plat and description is hereby annexed into the City of LaGrange. Henceforth, from the date of passage and publication of this ordinance according to law, the tract of land in the attached exhibit incorporated herein by reference is hereby incorporated into the City of LaGrange and is now part of said City.

## Annexation Description Citizens Union Bank to City of LaGrange Located at 2100 South Highway 53

BEGINNING at point in the westerly right-of-way line of Ky. Highway 53, said point being the northeast corner of a tract of land conveyed to Cedar Crest, Inc. by deed recorded in Deed Book 813 Page 102 in the Office of the Clerk of the County Court of Oldham County, Kentucky, said point also being a Corner of the Corporate Limits of the City of LaGrange, Kentucky; thence with the north line of Cedar Crest and with the line of the Corporate Limits of the City of LaGrange, S 42d 34m 54s W 210.13 feet to a point; thence N 47d 43m 08s W 244.15 feet to a point in the south right-of-way line of Pine Ridge Road; thence with said south right-of-way line, N 42d 38m 16s E 274.79 feet to a point in the westerly right-of-way line of Ky. Highway 53, aforesaid; thence with said westerly right-of-way line, S 41d 38m 52s E 145.58 feet to a point and S 21d 12m 41s E 110.39 feet to the point of beginning.

SAID property being located in Oldham County, Kentucky and containing all of the property conveyed to Citizens Union Bank (a/k/a Citizens Union Bank of Shelbyville, Inc.) by deed recorded in Deed Book 929 Page 80, in the Office, aforesaid. Said total area contains 1.423 acres. Said annexation area is shown on an Annexation Plat prepared by Garber-Chilton Engineers & Land Surveyors, Inc. and dated February 16, 2010 and revised on June 25, 2010.
