On motion of petitioners, by counsel, this action having come for hearing on order of the Court, and it appearing to the Court that a petition has been filed pursuant to KRS 81.050, and that notice of said hearing having been given in accordance with said statute, and the Court being advised on the petition herein of the fulfillment of the requirements of law which govern the creation of sixth class cities, and the Court being sufficiently advised,

IT IS THEREFORE ORDERED AND ADJUDGED that the following described area be, and is hereby established as a municipal corporation of the Sixth Class to be known as LANGDON PLACE, KENTUCKY:

BEGINNING at a point on the Southwest curb line of Goose Creek Road, 783.78 feet from the Northwest corner of Westport Road and Goose Creek Road, N 34° 43' 13" W 910.91 feet to a point; thence S 55° 16' 47" W 10 feet to a point; thence N 34° 43' 13" W 113.34 feet to a point; thence S 55° 42' 30" W 1055.44 feet to a point; thence S 34° 43' 13" E 522.96' to a point; thence S 12° 18' 35" E 368.64 feet to a point; thence S 78° 00' 00" W 62.90 feet to a point; thence S 13° 15' 55" E 143.21 feet to a point; thence N 77° 41' 25" E 473.01 feet to a point; thence N 72° 57' 46" E 75.35 feet to a point; thence N 61° 45' 28" E 103.16 feet to a point; thence N 55° 16' 47" E 140.31 feet to a point; thence N 35° 31' 07" W 19.04 feet to a point; thence N 55° 16' 47" E 592.07 feet to the point of beginning said parcel being approximately 30 acres.
