AN ORDINANCE RELATING TO THE ANNEXATION OF LAND OR TERRITORY TO THE CITY OF LAWRENCEBURG, KENTUCKY

WHEREAS, Robert N. Fryer, IV, and

Judith Lynn Einheit Fryer, husband and wife, 1224 Harrodsburg Road, Lawrence-burg, Anderson County, Kentucky 40342, are the owners of certain real property lying and being on the west side of South Main Street in the City of Lawrenceburg, Kentucky, and containing six (6) +/- acres which is adjacent to the presently existing corporate limits of the City of Lawrenceburg; and WHEREAS, Robert N. Fryer, IV, and

Judith Lynn Einheit Fryer have requested said real property containing six (6) +/- acres be annexed into the corporate limits of the City of Lawrenceburg, which proposed annexation is believed to be desirable for both said property owners and the City of Lawrenceburg; and

WHEREAS, said real estate is

presently classified as Low Density Residential (R-1);

NOW THEREFORE, Be It Ordained by

the Board of Council of the City of Lawrenceburg, Kentucky, convened in regular session, as follows:

1. That pursuant to KRS 81A.412, as the City of Lawrenceburg has received prior written consent of Robert N. Fryer, IV, and Judith Lynn Einheit Fryer, owners of the land to be annexed, and other applicable statutes, the Board of Council of the City of Lawrenceburg, Kentucky, desires to annex a tract of real estate, containing six (6) +/- acres, which will remain zoned Low Density Residential (R-1) following annexation, which is more particularly described as follows:

Being a certain tract or parcel of land lying on the west side of the Louisville and Crab Orchard Turnpike road and on the waters of Bailey's Run in Anderson County, Kentucky, bounded as follows, viz:

Beginning at a stone between the southeast corner of the Lawrenceburg Cemetery and the Louisville and Crab Orchard Turnpike, thence South 16 degrees 30 minutes East 6.68 chains to a stone in the Carpenter dirt road, thence with same South 47 degrees West 10.12 chains to a stone in the lands of Mrs. E. McKee, thence with her line to a stone in the southwest corner of the cemetery fence North 25 degrees West 9.50 chains, thence North 65 degrees 45 minutes East 10.34 chains to the beginning, containing eight acres and nineteen perches.

THERE IS EXCEPTED from the above described tract of real estate a portion thereof that was conveyed to the Lawrenceburg Cemetery Company, Inc., of Lawrenceburg, Anderson County, Kentucky, by Andrew Irwin McKee, et al., by Deed dated June 20, 1932, and of record in the office of the Anderson County Clerk, Lawrenceburg, Kentucky, in Deed Book 29, Page 196, and which said excepted portion of said real estate is more particularly described, as follows:

Beginning at figure (1) corner to the Lawrenceburg Cemetery on said road, thence with same South 14-3/4 degrees East 10 poles to (2) a stake corner to McKee heirs; thence with said McKee heirs South 67-1/4 degrees West 38.84 poles to a stake (3) in a division line, thence with said division line North 22 degrees -5 (sic) West 9.92 poles to (4) corner to the Cemetery, thence with the Cemetery North 67-1/4 degrees East 40 poles to the beginning, containing 2 acres, 1 rood, and 30-1/2 square poles.

The above described real estate, less said exception, is the same real estate which was conveyed to Eliza S. McKee, by Martha E. McKee, by Deed dated February 13, 1890, and by Martha E. McKee, by Deed dated February 13, 1890, and lodged for record in Deed Book U, Page 452, in the office of the Anderson County Clerk, Lawrenceburg, Kentucky. Thereafter, the said Eliza S. McKee died intestate a resident of Anderson County, Kentucky, on March 8, 1919, survived by her husband, L.W. McKee, who died thereafter, intestate, and unmarried, a resident of Anderson County, Kentucky, on January 15, 1930, and the said Eliza S. McKee was also survived by her children, Andrew Irwin McKee, Logan McKee. Miriam McKee Gerow, Jane McKee Fryer, Logan McKee, Miriam McKee Gerow, Jane McKee Fryer, Katherine Irwin McKee, and Robert S. McKee. See Affidavit of Inheritance of Eliza S. McKee dated July 8, 1932, and lodged for record in Deed Book 29, Page 196, in the office of the Anderson County Clerk, Lawrenceburg, Kentucky. Also see Affidavit of Inheritance of L.W. McKee dated June 10, 1930, and lodged for record in Deed Book 27, Page 485, in the office of the Anderson County Clerk, Lawrenceburg, Kentucky. Thereafter, one of the children of the said Eliza S. McKee, Katherine Irwin McKee died, intestate, unmarried, without issue, a resident of Anderson County, Kentucky, on October 3, 1937, survived by her only heirs at-law, her brothers and sisters, the said Andrew Irwin McKee, Logan McKee, Mariam McKee Gerow, Jane McKee Fryer, and Robert S. McKee. See Affidavit of Inheritance of and Robert S. McKee. See Affidavit of Inheritance of Katherine Irwin McKee lodged for record in Deed Book 107, Page 19, in the office of the Anderson County Clerk, Lawrenceburg, Kentucky, with each of said surviving brothers and sisters holding a one-fifth (1/5) undivided right, title and interest in and to the said real estate. The said Robert S. McKee, one of the holders of a onerife Sald Robert S. McKee, one of the holders of a one fifth (1/5) undivided right, title and interest in the above described real estate, died December 14, 1993, a resident of Marion County, Indiana, and on January 6, 1994, the Last Will and Testament of Robert S. McKee was admitted to probate in the Probate Division of the Superior Court, County of Marion, Indiana, in Probate No. 49D089401ES2, and which Last Will and Testament of Robert McKee devised all of the decedent's property to Jane McKee Ingram. A copy of the Last Will and Testament of Robert McKee has been lodged for record on August 2, 1994, in Will Book O, Page 289, in the office of the Anderson County Clerk, Lawrenceburg, Kentucky. The said Jane McKee Ingram is married to John Ingram, a/k/a Jack Ingram, who has joined in the making of this Deed of Conveyance to convey his inchoate curtesy interests in and to the one-fifth (1/5) undivided right, title and interest to the above described real estate.

2. That the real estate hereinabove described, which is owned by Robert N. Fryer, IV, and Judith Lynn Einheit Fryer, shall be annexed to the City of Lawrenceburg, Kentucky, in the manner and in accordance with procedures provided by the laws of the Commonwealth of Kentucky; and that the Mayor of the City of Lawrenceburg be and he hereby is authorized and directed to cause the advertisement of this Ordinance, pursuant to law, in The Anderson News, a newspaper of general circulation within the area to be annexed.






